Support for the Town of White City's Application to Alter Their Boundaries - Letter Template

The Town of White City has applied for boundary alterations to grow their community, proposing land be annexed from the RM of Edenwold. Some of the land includes commercial and residential developments.

The RM of Edenwold has not consented to the annexation, and the application has been referred to the Saskatchewan Municipal Board.

Saskatchewan's urban municipalities are hubs, providing services to not only local residents, but to those living in the surrounding RMs, often without any acknowledgement or contribution.

It is essential that hometowns grow in the most sensible and efficient way possible, to make best use of tax dollars at all levels. This growth sometimes leaves urban municipalities at odds with surrounding municipalities. However, this should not prevent an urban municipality from pursuing growth where it will be of the greatest benefit and least cost.

SUMA has drafted a letter template that Saskatchewan's hometowns can send to the Town of White City in support of their application, which has larger ramifications for all urban municipalities in Saskatchewan. Feel free to add any information that is important to your municipality. When sending the letter, be sure to cc the Saskatchewan Municipal

Applications Being Accepted for the Provincial Traffic Safety Fund Grant

Improve road safety in your community with a **Provincial Traffic Safety Fund Grant**.

The program provides up to \$100,000 (per location) to municipalities and Indigenous lands or territories. The goal of the fund is to stimulate and support local, collaborative action that will increase traffic safety awareness. Local traffic initiatives will help reduce collisions, traffic injuries, and fatalities. **Learn more**.

New PSE Locations

To curb speeding in your community, apply for photo speed enforcement (PSE) technology. New PSE technology locations will be recommended by the PSE Committee. Locations that may be eligible include high-risk, high-collision, and high-volume pedestrian areas. More information is available on SGI's website at www.sgi.sk.ca/photo-speed-enforcement.

Submit Your MRS Declaration of Eligibility by January 31

To receive Municipal Revenue Sharing for 2022-23, municipalities are required to submit a Declaration of Eligibility to the ministry and ensure their municipality meets all eligibility requirements.

The Ministry of Government Relations emailed municipalities their unique link and password for the online Municipal Revenue Sharing (MRS) Grant Declaration of Eligibility. The deadline for submission of the Declaration of Eligibility is January 31.

If your municipality did not receive the email and it is not in your spam/junk folder, email the ministry at grcompliance@gov.sk.ca.

A completed declaration requires a resolution from council confirming the eligibility requirements the municipality meets.

ADVOCACY UPDATE



Province in Support of Federal Government Absolving Costs of Retroactive RCMP Salaries

Last year, as part of a SUMA advocacy campaign on RCMP retroactive pay increases, we asked you to send a letter to

the federal minister of public safety requesting the federal government cover the retroactive salary costs.

We also advocated the province, asking the Honourable Christine Tell, Minister of Corrections, Policing and Public Safety, to support our position. In November, Minister Tell sent a letter to the Ministry of Public Safety requesting that the Government of Canada absorb the entire financial impact of the retroactive wage compensation for 2017-2021.

COVID-19 UPDATE

140 Million More Rapid Tests Heading to Provinces, Territories

On January 5, the Government of Canada announced that an additional 140 million rapid tests will be delivered to provinces and territories this month.

The tests are being allocated on a per-capita basis.

The Saskatchewan Health Authority (SHA) is hosting their first Town Hall Information Session of 2022 on January 18 at 3:00 p.m.

During the town hall, leaders from the SHA will:

- discuss the current state of COVID-19 in Saskatchewan;
- provide an update on the impact of COVID-19 on the health system; and
- provide an update on Saskatchewan's vaccine strategy.

Fourth Doses Recommended for Designated Immuno-Compromised Residents

Those who are moderately to severely immunocompromised and have had three doses for their primary COVID-19 vaccination series are eligible to receive a booster/fourth dose at least three months after their third dose.

These individuals include those who had received a letter of eligibility from the Ministry of Health, including people receiving chemo and immuno-suppressive therapies, those with HIV, or who have had organ transplants. Those groups now eligible are listed at saskatchewan.ca/covid-19.

Update Your QR Code After Your Booster

If you generated your COVID-19 vaccination record QR code following your second dose of vaccine, you will need to generate a new QR code after your booster dose if you want to show you have received the booster.

Once generated, QR codes are static and need to be updated when your vaccination status changes. You can access your MySaskHealthRecord account and generate a new QR code after receiving any COVID-19 vaccine, to ensure your record is up-to-date.
