ADVOCACY UPDATE

Steps Forward for Mental Health and Addictions Treatment

In recent announcements, the Government of Saskatchewan promised **14 new addictions treatment spaces at the Possibilities Recovery Center in Saskatoon**. The new addictions treatment spaces include ten for adults and four for youth, building on the 18 spaces that were announced in November of 2023. Also, earlier this month, the government announced a **new in-**



patient treatment facility consisting of 60 beds to be established at the former Living Skies Retreat & Conference Centre, which will be the largest in Saskatchewan to date. The facility will be located 20 minutes outside of Regina, near Lumsden.

The new facilities bring the total number of addictions treatment spaces that have been announced under Saskatchewan's Action Plan for Mental Health and Addictions to 168, working toward the government's new promise of 500 treatment spaces across the province.

These recent announcements are a direct result of SUMA's ongoing mental health and addictions advocacy efforts. As you know, SUMA has been asking for these very changes for some time, and while there is certainly more work to be done in addressing the breadth of MHA issues across the province, these developments are promising. We look forward to continuing our work with the government and seeing further progress in this area of advocacy.

Election Supplies and Ballots

Since the 1997 election, SUMA has been offering election forms, supplies and ballot printing to our members. It provides a one-stop shop for all SUMA members with the assurance that supplies will be upto-date, and a staff member available to answer questions or refer them to the appropriate contacts at Government Relations.

For ballots, SUMA members must ensure orders are placed a minimum of 15 business days prior to

advance poll date; this will allow ballots to arrive in time. Please note SARM members are only able to order supplies from SUMA, not ballots.

Member Advantages

- Substantial cost savings, based on bulk purchasing of supplies and bulk processing of ballots
- Election forms as prescribed by *The Local Government Election Act* accurately reproduced ready for use on election day
- Forms and supplies shipped using the most cost effective method for each individual municipality (within one to two business days of order receipt)
- When the order is received by the SUMA office within 15 business days prior to the advance poll date, guaranteed processing of ballot orders to meet the limited turn-around time between close of nominations, advance poll, and election dates. Orders received less than 15 business days prior to the advance poll date cannot be guaranteed.

Shipping Label Price Increase

Effective Jan 15, 2024, **there will be an increase in shipping label costs** (due to fuel surcharge increases).

Below are the new prices:

1.36kg will increase to \$456.25 per pack (currently \$436.69)
5kg will increase to \$542.00 per pack (currently \$488.78)

Note each pack contains 25 labels. GST is in addition to these prices.
