## Submit Your Application for Targeted Sector Support Funding Before February 1


There is only one week left to submit your application for the Targeted Sector Support (TSS) Initiative.

The TSS Initiative provides cost-shared grants for projects undertaken by two or more Saskatchewan communities which lead to:

- improved inter-community relationships and co-operation
- enhanced governance
- increased administrative capacity
- assistance for municipal transitions

TSS funding is a portion of Municipal Revenue Sharing used to encourage intercommunity collaboration and good governance in all Saskatchewan municipalities. The initiative is open to all municipal governments established by or under a provincial statute.

#### Boards of Revision Training and Certification

SUMA continues to work with the Ministry of Government Relations on the Board of Revision Renewal Initiative to strengthen and support Saskatchewan's property assessment appeal system.

The provincial government recently amended three municipal regulations to establish the Registrar and require all boards of revision to be certified to hear property assessment appeals for the 2023 taxation year.

For a board of revision to be certified, all its members and secretaries must successfully complete the developed online training program, which is now open for registration. A 50 per cent discount is being provided to the first 150 registrants using the code BOR2022 when registering. When the spots are filled, the code will expire.

#### CIF Summer Grant Deadline: February 1

Grant applications for the Community Initiatives Fund (CIF) Summer Grant Program are being accepted until February 1.

The Summer Grant Program supports standalone summer programs for children and youth participants under 18 years of age.

Types of programs typically supported include summer camps and day programs offering positive recreation, arts, culture and learning opportunities for children and youth. Summer grants are not intended to support school-related programs; summer fairs or events; adult or all-age programs that occur during the summer; or the summer portion of year-round programming. Summer programs must be held between June 1 and August 31.

## You're Invited to the Launch of a New Initiative to Support the Prevention of Firefighter Cancer

### Take Environment and Climate Change Canada's Survey on a Database for Municipal Organic Waste

Environment and Climate Change Canada has engaged Giroux Environmental Consulting to undertake an assessment of the merits and feasibility of a new national database for municipal organic waste management in Canada. As part of this assessment, they are gathering input on the level of interest among selected municipal governments and associations in Canada for a new national source of organic waste diversion information.

Municipalities are invited to complete a short survey (10 questions) to provide insight on this subject. The survey is active until **January 31**.

## Keeping Delegates Safe at Convention 2022

Delegate safety is SUMA's top priority. At Convention 2022, to reduce the transmission of COVID-19, we are introducing a number of safety measures. This includes **mandatory masking** and **proof of vaccinations**; a negative COVID-19 test will not be accepted in place of proof of vaccination.

We have also changed our cancellation policy for Convention



2022. Registrant cancellations can be made at any time, with a \$50 cancellation fee charged per cancelled registrant to cover a small portion of costs incurred. Substitutions of delegates can be made at any time without cost.

## More Information: SUMA Letter in Support of the Town of White City

## **COVID-19 UPDATE**

### **Expanding Treatment Options for COVID-19**

On January 17, Health Canada approved the use of Paxlovid, a new antiviral drug made by Pfizer. Paxlovid is an oral antiviral (pill) for COVID-19, recommended for people who test positive and are at high risk of severe outcomes including hospitalization or death.

Paxlovid is taken twice a day for five days by those with COVID-19. It stops the virus from multiplying, to help people overcome the infection and potentially recover faster.

Saskatchewan expected to receive a shipment of Paxlovid last week. Quantities are expected to be limited at first and increase throughout the year. Details on eligibility criteria and how to access this medication will be provided in the coming days.
