# Targeted Sector Support Initiative Now Accepting Applications

Applications are being accepted for Targeted Sector Support (TSS) Initiative funding now **until March 5**. TSS funding is a portion of Municipal Revenue Sharing (\$1.5 million per fiscal year) used to encourage inter-community collaboration and good governance in all Saskatchewan municipalities.

The TSS Initiative provides cost-shared grants for projects undertaken by two or more Saskatchewan communities which lead to:

- improved inter-community relationships and co-operation
- enhanced governance and administration
- increased governance and administrative capacity
- assistance for municipal transitions

#### Who can apply?

Applications for the cost-shared grant must be submitted by a municipal government established by or under provincial statute. Applicants must partner with other communities on proposed projects.

Other communities may include, but are not limited to, other municipalities, regional committees, district planning commissions, First Nations, organized hamlets, parks, etc.



# Don't Miss the January 31 Deadline: Municipal Revenue Sharing Grant

To avoid your municipality's Municipal Revenue Sharing Grant for the 2021-22 year being withheld, ensure your municipality submits its online Declaration of Eligibility by **January 31** and that your municipality meets all eligibility requirements.

The unique link and password for the online Municipal Revenue Sharing Grant Declaration of Eligibility was emailed to each municipality on November 13. If you did not receive the email, email grcompliance@gov.sk.ca requesting the email be re-sent.

Municipalities of Saskatchewan is offering a Municipal Leaders' Roles and Responsibilities (MLRR) workshop, part of MLDP, on March 2. If you missed the MLRR workshop in December, now is your chance! This course is held following municipal elections every four years.

For example, corporate sponsors may display signs, donate equipment, or provide coupons or giveaways. The survey will explore the type, extent, source, and value of food promotion in your recreation facility.

You can confirm your facility's eligibility for the survey in less than five minutes by clicking on the link before February 10. If you are eligible and your facility agrees to participate, the survey, funded by Health Canada, will be emailed to you.

The survey is voluntary and individuals should participate in compliance with their organization's policies and procedures. Survey respondents can choose the "Prefer not to say" option for any questions which may be subject to organizational policies relating to disclosure of information.

The insight gained from this project will help recreation facilities, practitioners, and policymakers understand the state of food promotion in recreation facilities.

#### **Get Ready For Resolutions**

Prepare for the resolutions session at Convention 2021 by reviewing the **resolutions package**. Resolutions are our chance to get municipal issues in the spotlight with media and other orders of government. We encourage members to get familiar with the resolutions and the session procedures to make the most of our time - there are four resolutions this year.

Voting for resolutions, along with Municipalities of Saskatchewan's Executive Elections, will take place **electronically**.

The unique link for voting in resolutions and the Executive elections will be sent directly to elected officials who are eligible to vote. A test vote will be held at the beginning of February to ensure that all elected officials who are eligible to vote are able to access the voting platform. A second test vote will be held prior to the presidential election. Technical support staff will be available should an individual have trouble accessing or using the platform.

We encourage our municipal members who have delegates registered for Convention to ensure that email addresses for their delegates are accurate, as the link to vote, in

addition to the link to access the platform, will be sent out directly to registered delegates.

More information will be provided regarding voting when the test vote is sent out to all eligible voters.
