The Community Initiatives Fund (CIF) is accepting applications for the Community Grant Program until April 1. The Community Grant Program supports programs under three funding themes: the healthy growth and development of children and youth; individual and community wellbeing; and nonprofit and community leadership.

Programs must begin no sooner than two months after the application deadline and must be no more than 12 months in length.

## **Updated Procurement Thresholds**

Saskatchewan is a party to a number of trade agreements, including the New West Partnership Trade Agreement (NWPTA), the Canadian Free Trade Agreement (CFTA), and the Canada-European Union Comprehensive Economic and Trade Agreement (CETA). Each of these agreements contain procurement provisions to which municipalities are subject. Unlike the fixed thresholds of the NWPTA, the CFTA and CETA procurement thresholds are adjusted for inflation

every two years.

Four-Part Heritage Webinar Series Starting March 1

- For uniformed government workers, the nomination form must be signed by the Deputy Minister.

# New 2022 Accessible Canada Calls for Proposals

Employment and Social Development Canada (ESDC) has launched two calls for proposals (CFPs) for the next cycle of Accessible Canada grants and contributions funding under the Social Development Partnerships Program (SDPP) - Disability component. The CFPs will remain open from **February 4** to **March 25**.

The funding will support projects that increase awareness of accessibility and inclusion to support the culture change objectives of the Accessible Canada Act; build capacity within the disability community to continue to engage on the implementation of the Act and its regulations; and, foster multi-sectoral and diverse partnerships to support innovation in accessibility.

## WorkSafe Saskatchewan Announces New Video Training to Help Support the Prevention of Firefighter Cancer

Firefighter cancer is the second leading cause of work-related occupational disease deaths in Saskatchewan. From 2010 to 2018, 23 per cent of work-related occupational disease fatalities in Saskatchewan were from firefighter cancers and in 2020, five firefighters lost their lives to cancer. To help address this, WorkSafe Saskatchewan has announced a new video resource series to help firefighters better protect themselves from incidents and exposures on the job.

The 31 videos in the series are based on best practices that were recommended for Saskatchewan fire departments to adopt after an audit of several professional and volunteer fire departments in 2019. visiting:

## WCB Extending Cost Relief for Work-Related COVID-19 Claims

The Workers' Compensation Board (WCB) has extended cost relief for injury claims that occur on or prior to June 30, 2022 for employers to cover costs for accepted work-related COVID-19 claims.

#### The WCB is continuing to accept <u>eligible</u> workplace COVID-19 claims.

For claims that occurred in 2020 and 2021, the WCB has provided more than \$5.6 million in cost relief for COVID-19 injury claims. The cost relief is funded through the WCB's occupational disease reserve as a temporary measure to aid Saskatchewan employers.

This cost relief extension is set to wrap up at the end of June. The WCB will continue to assess the impact of the pandemic to employers and workers, and will communicate next steps prior to June 30. Learn more about the WCB's cost relief extension.

# **COVID-19 UPDATE**

## PCR Testing Focusing on Populations at Elevated Risk

Saskatchewan Health Authority PCR testing will now focus on populations at elevated risk for severe outcomes.

All residents should be self-monitoring, self-testing, and self managing to help prevent the transmission of COVID-19. For more information on self-testing visit <u>http://saskatchewan.ca/.../testing-information/rapid-testing</u>.

## Updated COVID-19 Self-Isolation, Close Contact Protocols

On January 28, the **protocols for self-isolation and close contacts changed**. Residents who receive a positive test result on a PCR or rapid antigen test are now required to self-isolate for five days, regardless of vaccination status. Previously, unvaccinated residents who had tested positive were required to self-isolate for 10 days.

Close contacts of positive COVID-19 cases are no longer required to self-isolate, regardless of vaccination status. If you are a close contact to a confirmed COVID-19 case, you should self-monitor for symptoms and continue to use publicly-available rapid antigen tests for asymptomatic surveillance.

Parents and caregivers are also no longer required to notify schools about positive test results for the purposes of close contact notification. Those who test positive are required to self-isolate and will be absent from school and activities for the duration of the self-isolation period.
