ADVOCACY UPDATE

Municipal Collaboration

February has been a month of collaboration. We continued making headway on our cornerstone advocacy issue, mental health and addictions, and housing. The Government of Saskatchewan announced **20 supportive housing units in Regina**, and **SUMA staff met with the federal housing advocate to discuss affordable housing across Saskatchewan**.

We also met with the **Minister of Social Services**, **Gene Makowsky and Minister of Mental Health and Addictions**, **Seniors and Rural and Remote Health Tim McLeod** to discuss issues around SIS and SAID, homelessness, and mental health and addictions, including harm reduction measures.

Today, the Saskatchewan Broadband Action Committee, co-chaired by **SUMA and SARM, met** with the Minister of Crown Investments Corporation, Dustin Duncan, to discuss broadband rollout across the province. You can read the key recommendations from the committee <u>here</u>.

Tomorrow, SUMA will be attending the **Waterwolf Planning Forum** hosted by Waterwolf Planning Inc., a District Planning Commission, whose aim is **municipal cooperation through the pooling of resources, investments, and mutually compatible decisions.** Waterwolf's vision of municipalities with shared high infrastructure standards fits with SUMA's goal of seeing stronger hometowns.

Looking at what lies ahead in 2024, earlier this month, **SUMA CEO**, **Jean-Marc Nadeau**, interviewed with Municipal World. He talked about municipal challenges such as infrastructure gaps and the effects of changing weather, and the work that SUMA staff have been doing. You can read the interview <u>here</u>.

As we move further into the year, SUMA looks forward to collaborating with all organizations that share our vision and advocacy goals.

The Rural Transit Solutions Fund

The Rural Transit Solutions Fund is the first federal fund to target the development of transit solutions in rural and remote communities. It supports the development of locallydriven transit solutions, helping people who live in these communities. A minimum of 10% of the total fund amount is allocated to projects that benefit Indigenous populations and communities.

Under the Planning and Design Projects stream, eligible applicants can seek a grant of up to \$50,000 to support communities' projects to plan and design new or expanded transit solutions for their communities (e.g., public engagement, needs assessments, feasibility or viability studies, surveys and assessments of routes or modes of travel).

Applicants can submit their application through Infrastructure Canada's <u>Applicant</u> <u>Portal</u>. More information on application steps, guides, and Infrastructure Canada webinars can be found <u>here</u>.

Canada's Road to INC-4: Plastic Action

As part of Canada's efforts to demonstrate domestic leadership in tackling plastic pollution, Environment and Climate Change Canada (ECCC) will host a Plastic Action Zone (PAZ) on the margins of INC-4 at the National Arts Centre.

At the PAZ, key partners and stakeholders can convene, network, and host events to demonstrate domestic action, innovation, and collaboration across all levels of government, with Indigenous peoples, industry, non-government organizations, youth, international organizations, and researchers to end plastic waste and pollution.

ECCC is **now accepting applications for events that will make up the PAZ program**. The application intake process will be open until **March 8, 2024, at 11:59 EST**. Only applications submitted through the online form may be considered.

Annual Reporting Requirement for Building Officials Appointed, Cancelled or Suspended

The Construction Codes Act, which came into effect January 1, 2022, requires local authorities to advise the Chief Codes Administrator of the status of their building official appointments on an annual basis.

Within 60 days after the end of a local authority's fiscal year (by the end of February), the local authority must provide the Chief Codes Administrator with the name and licence number of every building official who, in the previous fiscal year:

- Was appointed;
- Had their appointment cancelled; or
- Had their appointment suspended.

There is no need to provide reports every time the local authority changes building officials – only the fiscal-year-end report is required.
