\$275 Million in Municipal Revenue Sharing for 2021-22

The Government of Saskatchewan has announced that more than \$275 million is being provided to municipalities in 2021-22 under the Municipal Revenue Sharing Program.

The amount of funding is based on three quarters of one

point of the provincial sales tax (PST) revenue collected from two years prior. From the total funding, \$1.5 million will be invested in the <u>Targeted Sector Support Initiative</u>. The initiative supports municipal projects that advance priority areas such as good governance, regional planning, and intercommunity collaboration.

Infrastructure Funding for 15 Hometown Projects

On February 9, the Government of Canada and Government of Saskatchewan announced more than \$13.6 million in joint funding for 30 infrastructure projects in Saskatchewan - 15 of the projects are located in Saskatchewan cities, towns, villages, and resort villages.

The hometown projects receiving funding focus on upgrading water and wastewater systems to position communities for the future, decommissioning landfills to help protect the environment, and improving recreation facilities for various sports and other activities.

Funding is through the Investing in Canada Infrastructure Plan. The Government of Canada is investing more than \$6.7 million and the Government of Saskatchewan is contributing more than \$6.9 million.

Canada Healthy Communities Initiative

Public spaces help make a community safe, vibrant, and connected. COVID-19 has seriously impacted access and use of public spaces.

The Healthy Communities Initiative is a \$31 million investment from the Government of Canada to support communities as they create and adapt public spaces to respond to the new realities of COVID-19. In Saskatchewan, the initiative is providing \$976,000 in funding.

Funding is available to a broad range of organizations, including local governments, charities, Indigenous communities, and non-profits, for projects, programming, and services that help communities:

- create safe and vibrant public spaces,
- · improve mobility options, and
- provide innovative digital solutions to connect people and improve health.

More Time to Apply for Universal Broadband Funding

The deadline for Universal Broadband Fund applications has been extended to **March 15**.

The \$1.75 billion Universal Broadband Fund was designed to fund broadband infrastructure projects that bring high-speed Internet at 50/10 Megabits per second to rural and remote communities.

Saskatchewan Health Authority Virtual Town Hall

Today at 3:00 p.m. the Saskatchewan Health Authority (SHA) is hosting another COVID-19 virtual town hall designed for stakeholders, including municipal leaders. The SHA will provide updates on topics including:

- Epidemiological trends and projections;
- Pandemic response offensive and defensive strategies; and
- Vaccination strategy.

COVID-19 Testing Recommended after Inter-provincial Travel

With the presence of new variants of COVID-19 across Canada, the Government of Saskatchewan is recommending that all individuals who choose to travel inter-provincially get tested as soon as they return to Saskatchewan and plan for a follow up test seven days later.

An individual does not need to be experiencing symptoms in order to have COVID-19. People who enter or re-enter Saskatchewan should self-monitor for 14 days and self-isolate at the first sign of even mild symptoms. At this time, it is not mandatory that a person self-isolate for 14 days upon their return from an out-of-province trip. Self-isolation is only mandatory for international travel. It is still recommended that individuals take all precautions and maintain a minimum of 2 metre distance with persons outside their household while travelling and upon return to the province.

The Government of Saskatchewan continues to recommend against all non-essential travel.

Congratulations Award Winners

On February 9, at Convention 2021, winning local governments received their Saskatchewan Municipal Awards.



1st Place: Request for Service App (City of Moose Jaw)

Winning Practice: Developed an app that records and tracks requests for service submitted by residents and provides valuable two-way communication between the city and its residents.

2nd Place: 737 Volunteer Fire Department (RMs of Souris Valley No. 7 and Lomond No. 37)

Winning Practice: Established a volunteer fire department to provide wildland fire fighting services to residents and ratepayers of both municipalities in addition to mutual aid to neighbouring municipalities and counties.

Regional Cooperation: Regional Rideshare Initiative

(Towns of Balgonie, Grand Coulee, Pilot Butte, Pense, and Lumsden, Villages of Buena Vista and Belle Plaine, RMs of Edenwold No. 158, Pense No. 160, Lumsden No. 189, Lajord No. 128, and Bratt's Lake No. 129)

Winning Practice: Developed a regional rideshare framework where member municipalities adopt complimentary bylaws allowing rideshare companies to operate within their municipality once the companies have obtained a regional rideshare license.
