Additional \$2.2 Billion for Federal Gas Tax Fund

On March 25, the Government of Canada announced doubling of the Federal Gas Tax fund for one year, and renaming of the fund to the Canada Community Building Fund.

The additional funding and name change is part of the federal government's proposed **Bill C-25**.

The Gas Tax Fund provides municipalities with a permanent, predictable source of long-term funding, enabling construction and rehabilitation of core public infrastructure. It offers communities the flexibility to make strategic investments in local infrastructure.

\$53 Million Announced for Recreation, Green Projects in Saskatchewan

On March 31 the Government of Canada and Government of Saskatchewan announced more than \$53 million in joint funding for 24 recreation and green infrastructure projects in Saskatchewan.

Recreation infrastructure projects include improvements to arenas, swimming pools, and outdoor facilities. Several water and wastewater infrastructure projects are also receiving funding to improve capacity to meet current and future demand while ensuring continued compliance with provincial and federal regulations.

The Government of Canada is investing more than \$31.1 million in these 24 projects through the Investing in Canada plan, with the Government of Saskatchewan providing more than \$22.7 million.


Building Near Railways - FCM-RAC Proximity Initiative

Canada's railways have played a fundamental role in communities across Canada for more than a century. From coast to coast, communities have been built around rail tracks.

But the practice of developing land in close proximity to railway operations, and the expansion of rail in urban areas, has caused some challenges for municipalities, developers, and railways. That's where the Proximity Initiative comes in.

Created jointly by the Railway Association of Canada (RAC) and the Federation of Canadian Municipalities (FCM), the goal of the FCM-RAC Proximity Initiative is to

New - Doing Business with the Ministry Website

The Ministry of Highways has officially launched its new Doing Business with the Ministry website.

The new URL for the site is www.saskatchewan.ca/highways-business. Be sure to update your bookmarks and use this URL moving forward. There is a new category structure on the site. Although there is a different structure, existing documents were not revised.

The new site has many features not previously available. These include:

- A search function
- The ability to tag specific documents

By providing the public with up-to-date resources and information on rail infrastructure and operations, municipal planning guidelines, and a dispute resolution process, the Proximity Initiative is helping to bridge any gaps between railways and residents, while pursuing common goals that will benefit communities, railways, and the country as a whole.

Ban On Pruning Elm Trees In Effect

The annual ban on pruning elm trees in Saskatchewan to help curb the spread of Dutch elm disease (DED) is in effect now until August 31. During this period, it is illegal to prune elm trees.

The ban occurs at the time of year when the elm bark beetles that spread DED are most active. Fresh cuts from trimming trees can attract the tiny insects, increasing the chance of an infection.

Tips for Protecting Elms in Your Community:

- Prune elms before or after the ban period to keep them healthy and better able to resist all types of disease, including DED.
- Remove unhealthy and dead elm wood cuts, reducing places for beetles to breed and the risk of infection.
- Remove and dispose of DEDinfected elms promptly, including



Updated Recycling Database for Saskatchewan Residents

The Saskatchewan Waste Reduction Council has announced an updated recycling database. Saskatchewan residents can now enter their community and what they want to recycle to see a list of options, including a map of locations and details.

Further plans to enhance the database in 2021 include the addition of "Pass it On" and "Repair" information. Consumers will be able to find options to keep products in use longer by fixing them or giving them away. Adding these options helps Saskatchewan residents move toward a more circular economy, where keeping resources in use as long as possible and recycling only at the end of life are key factors.

The "Pass it On" and "Repair" features will be available in the fall of 2021.

Saskatchewan Health Authority Virtual Town Hall

The next COVID-19 virtual town hall hosted by the Saskatchewan Health Authority is scheduled for April 12 at 3:00 p.m.

The Saskatchewan Health Authority, who has been hosting virtual town halls weekly for stakeholders, is moving the event to a biweekly schedule.

All Public Health Measures Extended Until April 12

The provincial public health orders announced March 9 and the Regina and area revisions announced March 24 have been extended to **April 12**.

In Regina and area:

- Private gatherings are prohibited.
- All restaurants and licensed establishments are closed for in-person dining; take-out and delivery is permitted.
- Event venues including banquet and community halls, conference facilities, arts venues, museums, libraries, live theatre, cinemas, arcades, bowling and science centres, or any non-essential indoor locations that had limits of 30 individuals are not permitted to operate at this time.
- Places of worship remain at current capacity, which is a maximum of 30 individuals.
- Travel is also not recommended in or out of the area unless absolutely necessary.
- It is strongly recommended that all individuals in the Regina area able to work from home do so.

These additional measures apply to the city of Regina and area including: Belle Plaine, Pense, Grand Coulee, Lumsden Beach, Regina Beach, Craven, Lumsden, Edenwold, Pilot Butte, White City, Balgonie, Kronau, Davin, Gray, Riceton, RM of Lajord, RM of Edenwold, RM of Sherwood, RM of Pense, and the RM of Lumsden.

Provincially:

- Masks are mandatory in all indoor public spaces.
- All private dwelling indoor gatherings are limited to a maximum of 10 individuals (excluding Regina and area).
- Outdoor gatherings limited to maximum 10 people (People in attendance must ensure that physical distancing of at least two metres between households is maintained).
- Visits to long-term care and personal care homes suspended except for compassionate reasons.

With earlier than expected allocations of the AstraZeneca vaccine, the Saskatchewan Health Authority is expediting the opening of additional drive-thru and walk-in vaccine clinics in communities including Regina, Saskatoon, Yorkton, Moose Jaw, Weyburn, Swift Current, Prince Albert, Lloydminster, and North Battleford.

Clinics will be available to residents 55 years of age and older. All of these clinics will be first come first serve.

Advocacy Update

Canada Water Association

The Minister of Environment and Climate Change Canada, in conjunction with the Minister of Natural Resources and Special Representative for the Prairies, has been mandated to create a Canada Water Agency (CWA), with inputs from provinces, territories, Indigenous communities, local authorities, and others to ensure Canadian water is clean, safe, and properly managed.

Municipalities of Saskatchewan welcomes this initiative and has endorsed a letter of support to the Minister of Environment and Climate Change to have the CWA head office located in Regina.

Municipalities of Saskatchewan believes that the economic benefits such as job creation of locating the CWA in Regina are immeasurable and will add value.
