

Cyber Security Best Practices for Municipal Leaders

TECHNATION Canada, along with their Industry Cybersecurity Best Practices Advisory Group, has released the <u>Municipal Cybersecurity Best Practices</u> Saskatchewan residents to turn in polluters when they see illegal dumping.

Illegal dumping and burning of plastics, tires, and other waste are environmental violations. Saskatchewan's TIPP service -Turn in Poachers and Polluters - is for wildlife, fisheries, or environmental violations.



Amending Your Council Procedures Bylaw

A recent amendment to section 81.1 of *The Municipalities Act* and to section 100.1 of *The Northern Municipalities Act*, 2010 requires that a **council procedures bylaw have provisions for designating a person to call a special meeting if the position of administrator is vacant or the administrator is unable to act**.

It is recommended that a municipality's council procedures bylaw is amended as soon as possible to accommodate this amendment. This could be especially important to have in place during the uncertain times of the pandemic should an administrator fall ill with COVID-19. It is a good idea for council and administration to consider what they will do if the administrator is unable to attend meetings.



Community Planning Education

Land use planning is voluntary in Saskatchewan. Municipalities can choose to regulate development within their boundaries through an official community plan and zoning bylaw, and regionally with neighbouring communities through a district plan. All municipal and district level land use bylaws must be consistent with *The Planning and Development Act,* 2007 and *The Statements of Provincial Interest Regulations.*

To help, Community Planning has released the webinar **Planning 101** which covers a broad cross-section of Saskatchewan land use and community planning fundamentals.

Cleanfarms Releases 2020 Annual Report

Cleanfarms has released its 2020 Annual Report highlighting the performance of its permanent programs and pilot projects that recover used agricultural products and packaging for recycling or environmentally responsible disposal.

The recovery numbers reflected in the report show Canadian farmers will use environmental programs that help them manage agriculture waste like pesticide and fertilizer containers, grain bags, baler twine, unwanted and old pesticides, livestock and equine medications, seed and pesticide bags, and more when they have access to them. climate competence, and benefit from these shifting global preferences?

Despite the challenges of a year restrained by the COVID-19 pandemic, farmers/producers returned more than 5.5 million pesticide and fertilizer jugs 23 litres and smaller, on par with 2019 numbers when there was no pandemic to interfere with the open dates of collection locations. The 2020 collection brought the total number of jugs recovered for recycling since the beginning of the program in 1989 to more than 137.4 million.

Second Dose Booking Now Available to Priority Populations

As of May 17, anyone who is 85 and older or anyone who received their first dose before February 15 is eligible to book their second dose of COVID-19 vaccination.

The SHA online patient booking system will be able to make booked clinic appointments for second doses starting at 8:00 a.m. on Tuesday. Today, second dose vaccinations are available at participating pharmacies across the province, through the Saskatchewan Health Authority (SHA) drive-thru and walk-in clinics, as well as through clinics operated by Indigenous Services Canada and the Northern Inter-tribal Health Authority (NITHA).

Vaccine-Related Thrombosis Confirmed in Saskatchewan

The province of Saskatchewan has confirmed the first case of vaccine-induced immune thrombotic thrombocytopenia (VITT). The patient is a female aged 60-69 who had received the AstraZeneca/COVISHIELD vaccine on April 11. She has received treatment and is recovering.

At this time, public health is planning to offer the second dose of COVID-19 vaccine to match the brand of the first dose received. However, national reviews of the safety and efficacy of interchanging the second dose brand are ongoing. As more evidence comes forward suggesting mixing brands is safe and based on the brand allocations received in Saskatchewan, public health recommendations on second doses may be updated.
