Join SUMA's Municipal Immigration Network

Immigration helps strengthen communities, addressing labour shortages, improving economic sustainability, and supporting local recovery from the pandemic. Municipal governments have a significant role to play in attracting and welcoming immigrants. To assist Saskatchewan hometowns interested in fostering immigration in their community, SUMA is establishing the Municipal Immigration Network. Through this network, hometowns will have the opportunity to: work closely with organizations that support immigrants; share information; learn best practices of how to attract, welcome, retain, and integrate immigrants; and promote regional collaboration.

This network is open to municipal leaders – both elected officials and administration – from SUMA member municipalities. Space in the network is limited. Members will be selected randomly, with consideration given to ensure that different sectors and regions are represented. is underway. We also update each active resolution with the responses we receive from the provincial or federal governments and the work we are doing on that resolution. with the Queen Elizabeth II Platinum Jubilee Medal.

The commemorative medal celebrates the 70th anniversary year of Her Majesty Queen Elizabeth's II's accession to the Throne. A total of **7,000 medals will be presented** through the Platinum Jubilee year, which ends on February 5, 2023.

To be eligible for a medal, the recipient must:

- be a **resident of Saskatchewan** or have a link to Saskatchewan (at the time of the grant of the medal);
- have made a contribution to Canada, Saskatchewan, or a particular region or community; and
- be **alive on February 6**, **2022**, the 70th anniversary of Her Majesty's accession to the Throne.

To distribute the medals, the Government of Saskatchewan has partnered with several organizations. SUMA, along with SARM and New North, are administering nominations for smaller municipalities. Cities received their medal allocations directly.




New Provincial Cabinet Announced

Premier Scott Moe announced changes to the provincial cabinet that saw **five MLAs in cabinet given new portfolios** and **two MLAs entering cabinet**.

The five MLAs who remain in cabinet with new cabinet portfolios:

- Jim Reiter becomes Minister of Energy and Resources.
- **Bronwyn Eyre** becomes Saskatchewan's first-ever female Minister of Justice and Attorney General.
- Gordon Wyant becomes Minister of Advanced Education.
- Gene Makowsky becomes Minister of Social Services.



Take in Fall Policy Workshops with JSGS

The Johnson Shoyama Graduate School of Public Policy (JSGS) has released their fall policy workshop series designed for public sector employees who are involved in the development and implementation of programs and policies.

Public sector organizations include provincial, federal, and municipal governments, Crown organizations, Indigenous organizations and governments, universities and other educational institutions, and non-profits.

Registration opens on Thursday at 1:00 p.m. for employees of:

• select treasury board crowns,

• Lori Carr becomes Minister of SaskBuilds and Procurement, Minister Responsible for the Public Service Commission, and Minister Responsible for Saskatchewan Liquor and Gaming Authority.

The two MLAs who entered cabinet:

- Jeremy Cockrill becomes Minister of Highways, with responsibility for the Water Security Agency.
- Dana Skoropad becomes Minister of Environment.

The size of cabinet remains unchanged at 18, including the Premier. <u>See the full</u> <u>announcement</u>.



PEBA Transitioning to Non-Profit Corporation

The Public Employees Benefits Agency (PEBA) is pursuing a new operating structure as a non-profit corporation, separate from the Government of Saskatchewan.

The new non-profit corporation will be jointly owned by the Public Employees Pension Board (67,000 members and \$12 billion in assets) and the Municipal Employees' Pension Commission (26,000 members and \$3 billion in assets) who spearheaded the change.

PEBA says there will be no changes to the pension and benefits plans that they manage, and members and participating employers will not be impacted in any way.

In 2022, a legislative process will begin to allow PEBA to operate as a non-profit corporation, separate from the Government of Saskatchewan. It is anticipated this transition will be complete by 2024. including Saskatchewan Liquor and Gaming Authority (SLGA), Saskatchewan Crop Insurance Corporation (SCIC), Tourism Saskatchewan, and Water Security Agency (WSA)

- boards, crowns, and agencies within the Government of Saskatchewan who do not have access to the PSC Client system
- public servants in federal or municipal government
- Indigenous organizations and governments
- universities and other education institutions
- non-profit organizations

- Outstanding Contribution to Emergency Management



WCB's COVID-19 Cost Relief Concluding at End of June

The Saskatchewan Workers' Compensation Board (WCB) will conclude providing COVID-19 cost relief for employers with accepted COVID-19 workplace injuries that occur on or after July 1, 2022. Accepted COVID-19 workplace injuries that occur prior to July 1, 2022 are still eligible for cost relief.

The number of COVID-19 claims requiring workers to be away from work for more than 10 days has dropped significantly, from 41.9 per cent of claims in 2021 to 24.5 per cent of claims in the first part of 2022.

COVID-19 UPDATE

Weekly COVID-19 EPI Report

Each week, the Ministry of Health releases a COVID-19 integrated epidemiology (EPI) report that includes laboratory-confirmed cases, deaths, tests, vaccination information, hospital and census trends, and distribution of rapid antigen tests.

For the week of May 22-28:

- 5,667 laboratory tests were performed in Saskatchewan. The number of tests was lower than the number of tests in the previous week.
- One in nineteen laboratory tests were positive, which is a decrease from the previous week.
- 364 new cases were confirmed, lower than the number of new cases in the previous week.
- The majority of laboratory-confirmed cases this week were 50 years and older (52.5 per cent).
- There were nine newly-reported COVID-19 deaths, lower compared to the previous week.
- Three confirmed COVID-19 outbreaks in long-term care and care home settings were reported.
- As of May 28, 2022, of the population five years and older, 85.9 per cent received at least one dose of a two dose COVID-19 vaccine and 81 per cent completed a series.
