

The core mandate of the Town Caucus and Village and Resort Village Caucus is to provide a forum for the management of advocacy topics considered relevant to Saskatchewan towns and villages and resort villages, respectively.

The Caucus role includes the following responsibilities:

- Facilitating the meeting of the Caucus
- Identifying and providing advisory input on advocacy topics relevant to member urban municipalities in your sector
- Prioritizing advocacy topics and contributing to the setting of strategies required to advance the advocacy interests of the Caucus
- Providing input on provincial, federal, and/or collective advocacy topics
- Contributing to SUMA's communication efforts with the interest of keeping sector members informed and engaged

The Town Caucus and Village and Resort Village Caucus each meet virtually for approximately 90 minutes on a quarterly basis. Additional participation in events such as the Regional Roadshow and caucus meetings at Convention are also strongly encouraged.

2026 CALL FOR RESOLUTIONS

deadline **JANUARY 31, 2026**

REAL District - Regina, Saskatchewan
APRIL 12- 15

SUMA invites members to **submit resolutions ahead of the 2026 SUMA Convention and Tradeshow in Regina, Saskatchewan, from April 12 to 15**. Resolutions are an important way to bring forward issues confronting urban councils that require action by the provincial or federal government or another agency. Members are encouraged to submit resolutions on anything throughout the year. However, the **deadline for receipt of council resolutions for Convention 2026 is January 31, 2026**.

After concerns were raised by members about late resolutions and the inability for councils to discuss these resolutions in advance, only those late resolutions that are absolutely critical and could not possibly have been submitted early enough to be included in the Convention package will be brought forward, and only then with justification for why it is both urgent and emergent. Any other late resolutions will be considered by the SUMA caucuses after Convention.

Read the Full Call For Resolutions and Learn How to Submit

SUMA's move to a caucus model of governance has resulted in related changes to our resolutions process. While in previous years, we have had a resolutions committee review and recommend resolutions to our Board of Directors, this function will now be taken on by our sectoral caucuses. **Members should still forward their resolutions to the SUMA office in Regina, but it will be our caucuses that review and make recommendations to the Board as to which resolutions should proceed to the Convention floor.**

The number of proposed resolutions to be voted upon at Convention from each caucus has been limited to two. The caucuses may still choose to work independently on additional resolutions without full membership endorsement (i.e., resolutions that have not been brought forward and passed at Convention).

Submission of Resolutions

Members submit resolutions to SUMA. Resolutions can be submitted anytime, however, the deadline for consideration at Convention 2026 is January 31, 2026.



Review of Resolutions by Caucuses

Each caucus reviews resolutions.

Each caucus chooses two (2) resolutions to recommend to the Board.



Recommendation of Resolutions to Board

Board reviews resolutions recommended by each caucus.

Board provides resolutions package to members (March 2026).



Endorsement of Resolutions

SUMA members vote on resolutions at Convention 2026 (April 12-15).

While this represents a substantial change for our membership, it is meant to emphasize the intent of our Convention resolutions session: to bring additional media and government attention to those resolutions that will best benefit from that attention. Not every resolution requires this level of attention; many are better dealt with internally in discussions between SUMA elected officials or SUMA staff and their counterparts in the provincial and federal government. Members will still retain the ability to bring their concerns forward through resolutions, in addition to many opportunities provided through engaging with your caucus representatives, contacting SUMA staff, or attending our numerous events, including Convention.

Once resolutions have been recommended to the Board by each caucus, the Board will review and provide a package to all members in March 2026.



Why the Targeted Sector Support (TSS) Funding Grant Matters

Municipalities often face resource constraints, administrative hurdles, and governance complexities for starting new or costly initiatives beyond normal operations of the municipality. **Targeted Sector Support (TSS) Grant Funding** directly addresses these issues by reviewing applications to fund **75% of these costs** with the intent to:

- **Encourage Inter-Community Collaboration:** Projects must involve at least one partner municipality or community, fostering regional unity and shared solutions.
- **Enhance Governance and Capacity:** Funding supports training, restructuring, and strategic planning that elevates municipal leadership and administration.
- **Drive Innovation in Service Delivery:** From emergency management plans to regional land use strategies, TSS-funded projects improve efficiency and responsiveness.

Each project can receive up to **75% of eligible costs, capped at \$100,000 maximum funding**, making it a high-impact, low-barrier opportunity for municipalities to innovate and grow.

TSS is a portion of Municipal Revenue Sharing (\$1.5 million per fiscal year) used to encourage inter-community collaboration, help build capacity and promote good governance in all Saskatchewan municipalities. The funds are used to support projects that help municipalities strengthen their core governance and administration responsibilities

The TSS Steering Committee is now accepting applications for funding under this program. **Applications are accepted at any time of the year and will be reviewed on a monthly basis.**

Facilitating Independence Grant: Call for Applications

The **Saskatchewan Seniors Mechanism** (SSM), in partnership with the **Government of Saskatchewan's Ministry of Health**, will once again be providing one-time grant funding to senior-serving organizations and communities in Saskatchewan. The **Facilitating Independence Grants** (FIG) support projects that enable older adults to remain independent and continue living safely and comfortably in their own homes and communities.

These efforts may include maintaining and improving health and wellness, ensuring access to safe and reliable transportation, supporting appropriate and accessible housing options, and creating opportunities for social participation and inclusion. Equally vital is effective communication—ensuring that older adults can access information in a clear manner, regardless of their preferred format or technology skills.

The overall goal of FIG is to fund initiatives that provide meaningful programs with supports, and options, which empower older adults to live a freely chosen, purposeful life within their communities. More information about FIG will be available soon on the SSM Website - including eligibility criteria, application procedures, and key timelines.

The Honourable Maninder Sidhu, Minister of International Trade, recently announced the launch of **public consultations on four free trade agreement negotiations**. Each of these agreements has the potential to create business opportunities and improve market access for Canadian goods and services in several fast-growing economies around the world.

As part of Canada's work to double Canadian exports to non-U.S. markets in the next decade, these agreements will help build stronger and more reliable trade relationships around the world.

Public consultations will help shape Canada's negotiating positions, ensuring benefits are maximized for Canadians by reflecting their specific interests and priorities.

Landfill Methane Regulations: Upcoming Webinar

On December 16, 2025, the Minister of the Environment, Climate Change and Nature [announced](#) final regulations to reduce methane emissions from landfills across Canada. Information on the **Landfill Methane Regulations** (LMR), including a pdf version of the regulatory text and Regulatory Impact Analysis Statement, is now available on the [LMR webpage](#). The Regulations came into force on December 12, 2025 and will be published in *Canada Gazette*, Part II on December 31, 2025.

Environment and Climate Change Canada (ECCC) has also finalized updates to the Technical Guidance Document on Estimating, Measuring and Monitoring Landfill Methane and the accompanying Landfill Methane Modelling Tool. These documents are referenced in the Regulations and provide guidance on the quantification, measurement and monitoring methods included the new regulations. These resources can be accessed via the [LMR Google drive](#) – a repository of documents that has been established to provide access to documents and tools referenced in the Regulations and to support awareness of regulatory requirements.

The **Canadian Municipal Barometer** (CMB) will launch its **annual survey of Canadian mayors and councillors** on January 5th. This survey is part of an ongoing initiative to better understand elections, representation, inclusion, and policy in municipalities across Canada.

Workers Compensation Board Offering Site Visits to Improve Workplace Safety

From 2020 to December 2025, the **Saskatchewan Workers Compensation Board** accepted 32 workplace injury claims involving "Graders, levelers, planers, scrapers." This number does not include any near misses or incidents not resulting in a medical visit.

A recent visit to an RM identified the changing of grader blades as a potentially high-risk task. Accordingly, WCB is reaching out to see:

- Is this task a safety concern for your workplace?
- Do you have a safe work procedure for this task to prevent injuries resulting from contact or poor ergonomics? If so, can you share a copy?
- What engineering controls are being used to reduce the risk of injury?

Ideally, the **WCB is looking for 10 workplaces to host a site visit from an occupational therapist (OT)**. The OT, who is paid for by the WCB, will analyze the task being performed and provide coaching on modifications and recommendations. These recommendations can then be

used to inform the creation of a general safe work practice template that can be shared provincially. **The OT visit can focus on grader blades or any other job tasks that are of higher concern in your workplace.**
