Don't Miss the Town, Village, and Northern Sector Meeting

The Town, Village, and Northern Sector Meeting is happening online **June 18**. In addition to member driven discussions, the meeting will include updates from Municipalities of Saskatchewan, a keynote address by thought leader Stuart Knight, and an education session on emergency preparedness and wildfire management.



Natural Resources Canada is projecting that western Canada could see a wildfire season that's "well above average," with the possibility of an elevated threat of wildfires in parts of Saskatchewan stretching into September.

In this education session, Saskatchewan Public Safety Agency representatives Bud Sabean, Forest Protection Officer, Larry Fremont, Education and Prevention Coordinator, and Trevor Leggett, Emergency Services Officer, will talk about emergency preparedness, FireSmart, and the role of municipalities in wildfire management.

Municipal Economic Enhancement Funding Now Available

Funding through the Municipal Economic Enhancement Program (MEEP) is now live, meaning municipalities that have submitted and had their project plans approved by



the Ministry of Government Relations can start accessing funds within the program.

Announced May 6 as part of the Government of Saskatchewan's \$7.5 billion, two-year capital plan, MEEP 2020 is providing \$150 million in funding to municipalities to help stimulate Saskatchewan's economic recovery from the impacts of the COVID-19 pandemic.

All Saskatchewan municipalities are eligible for MEEP. To participate, municipalities need to submit:

- a signed funding agreement;
- a project plan identifying which project or projects will be funded; and
- a council resolution supporting the projects.

Application packages were mailed to all municipalities. If your municipality did not receive the application package, you are encouraged to

contact mifprovgrants@gov.sk.ca.

MEEP funding is being distributed to individual municipalities on a per capita basis, based on 2016 Canadian Census population numbers.

North Central Transportation Planning Committee -Municipal Support Program

The challenges and opportunities presented by sustainable infrastructure development has prompted the North Central Transportation Planning Committee to launch the Municipal Support Program.

The Municipal Support Program is geared towards assisting municipalities:

- with bidding on Road Building tenders
- in tender opening
- with direction in developing credible Asset Management Plans
- in locating gravel sources within your municipality
- with liaising between your municipality and third parties

The program is free to members of the North Central Transportation planning Committee. Non-members will be charged \$150 per day and \$0.50 per kilometre to cover mileage for a program advisor to come to your municipality.

Advocacy Update



Federal Emergency Funding for Municipalities

Municipalities are providing essential services and working to ease financial burdens for local residents and businesses during the COVID-19 pandemic, while being hit with new expenses and experiencing significant drops in revenue.

Data from the Federation of Canadian Municipalities (FCM) shows that municipalities are facing a minimum of \$10-15 billion in near-term, non-recoverable losses due to COVID-19. Municipalities of Saskatchewan has publicly called for federal emergency funding, supporting the Federation of Canadian Municipalities' call for at least **\$10 billion in emergency operating funding** for municipalities.

Municipalities can help advocate for federal funding by sending a letter to your Member of Parliament.

On June 5 the federal government announced \$14 billion for Canada's provinces and territories to help re-open provincial economies, with some of the money meant to **help municipalities continue providing core public services such as transit**.

CBC has reported that in a call with Prime Minister Justin Trudeau regarding the \$14 billion in federal funding, Saskatchewan Premier Scott Moe pressed the Prime Minister on the inflexibility of the funding, arguing municipal budgets in Saskatchewan do not need the extra cash to provide services, while other areas of the province's budget do need help.

Municipalities of Saskatchewan is continuing to advocate for provincial and federal funding.
