The Office of the Saskatchewan Information and Privacy Commissioner is an independent office of the Saskatchewan Legislative Assembly. It oversees three Saskatchewan statutes: The Freedom of Information and Protection of Privacy Act, The Local Authority Freedom of Information and Protection of Privacy Act, and The Health Information Protection Act. All three establish access to information and privacy rights of citizens.

The Information and Privacy Commissioner ensures that public bodies including municipalities respect the privacy and access rights of Saskatchewan citizens by:

- Informing the public of their information rights
- Resolving access and privacy disputes between individuals and public bodies
- Making recommendations on appeals from access to information decisions by public bodies
- Investigating and resolving privacy complaints
- Issuing recommendations on public bodies and practices
- Commenting on proposed laws and policies

Ombudsman Saskatchewan is the office of the provincial ombudsman, who is an independent and an impartial official. The

Therefore, for any questions regarding access to information and privacy rights of residents, municipalities should contact the Office of the Saskatchewan Information and Privacy Commissioner, and for complaints about elected officials, municipalities should contact Ombudsman Saskatchewan.

Municipal Audits: What's the Cost for Your Municipality?

The Cities Act and The Municipalities Act require each municipality to submit a copy of its annual audited financial statement and auditors report to the Ministry of Government Relations.

The financial statements are to be audited by a professional auditor - a person in good standing of a recognized accounting profession under *The Accounting Profession Act, 2014* - and must be prepared in accordance with Public Sector Accounting Board standards.

The Government of Canada is accepting applications for new projects through the Small Projects Stream of the Natural Infrastructure Fund.

The **\$200 million fund** supports building community awareness of the value of natural infrastructure.

Municipalities, local governments, provinces or territories, public sector bodies, Indigenous organizations, not-for-profit, and for profit organizations in partnership with other eligible applicants outside the private sector, can apply for up to \$1 million dollars in federal funding to restore and enhance natural infrastructure like urban forests, street trees, wetlands, living dykes, and bioswales.

\$1.34 Million for 85 New Traffic Safety Projects

A total of 85 applications from 80 Saskatchewan communities have been approved for Provincial Traffic Safety Fund grants. The communities will receive grants ranging from \$2,250 to \$92,601 for their projects which range from installing pedestrian pathways to increasing speed limit signage.

Provincial Traffic Safety Fund grants are awarded to communities twice a year, using proceeds from Photo Speed Enforcement.

Federal Government Pauses Billing of Retroactive Pay Increases for Municipalities

The Government of Canada has announced that it will pause billing of the retroactive portion of RCMP salaries to municipalities while it discusses with other orders of government how to handle the retroactive portion of the wages.

SUMA sees the pause as positive and we want to thank all municipalities who have participated in our advocacy efforts, including our letter writing campaign that sent letters expressing municipal concern over the backpay directly to the federal minister of public safety.

We will continue to call on the federal government to absorb the full cost of the retroactive pay as municipalities were not at the table when the decision was made and we know these additional costs have real impacts on Saskatchewan's communities.
