Shape SUMA's Bylaw Project -Take the Bylaw Enforcement Survey

SUMA is undertaking a municipal bylaw project, looking into different methods for adjudicating and enforcing bylaws. As part of the project, the following survey has been created to gather data on the current state of bylaw enforcement in Saskatchewan.

Municipalities are invited to help inform our bylaw project by completing the bylaw survey. We are looking for **one response per municipality**.

Property assessments are fundamentally important to municipal budgets. Provincial legislation requires all properties in Saskatchewan be revalued once every four years. With 2021 being a revaluation year, local governments across Saskatchewan are working with updated property values, and a new cycle of notices and appeals.

On **August 10** at **10:00 a.m.**, we are bringing together a panel of Saskatchewan Assessment Management Agency representatives and assessment lawyers to discuss the big issues in assessment, from revaluation to appeals.

Share Your Experience with *The* Local Improvements Act

Has your municipality used *The Local Improvements Act, 1993* to fund municipal capital works at any time in the last 10 or so years? If your answer is yes, the Ministry of Government Relations would like to hear from you.

The Act allows for special levies on specific properties in a municipality benefiting from a proposed work. They are used to fix, upgrade, or maintain a wide range of infrastructure works or services from sidewalks to back alleys.

Apply for Rail Safety Improvement Funding

Transport Canada is accepting applications for infrastructure, technology, and research projects for 2022-23 funding under the Rail Safety Improvement Program until August 1.

The program provides federal funding in the form of grants or contributions to provinces, territories, municipalities, and local governments, road and transit authorities, crown corporations, for-profit and not-for-profit organizations (including academia), Indigenous groups, communities and organizations, and individuals to help improve rail safety and reduce injuries and fatalities related to rail transportation.

Cleanfarms Collecting Unwanted Agricultural Pesticides This Fall

Cleanfarms is gearing up to run its 2021 fall collection program for unwanted agricultural pesticides and obsolete livestock, equine, and poultry medications.

Collection will be happening in northern Saskatchewan from **October 4-8**.

Accepted materials include:

- old or unwanted agricultural pesticides
- commercial pesticides for golf courses and industrial and commercial pest control products
- livestock/equine medications that are used in rearing animals in an agricultural context



Boaters Reminded to Stop at Watercraft Inspection Stations

Saskatchewan residents travelling across provincial and international borders with boats are reminded to keep an eye out for inspection stations along highways and near waterbodies.

The requirement to stop at all watercraft inspection stations is part of a coordinated effort to prevent the introduction and spread of aquatic invasive species (AIS). AIS not only have the potential to harm aquatic habitat and fisheries, but can also cause damage to important infrastructure related to power and water management, costing millions of dollars each year.
