Changes to The Statements of Provincial Interest Regulations

Amendments have been introduced to *The Statements of Provincial Interest Regulations*. On July 16, amendments to the regulations were approved and filed with the Registrar of Regulations. The amendments will come into effect on **January 1, 2021**.

Amendments to the regulations are designed to:

- Improve predictability of agricultural activities in Saskatchewan;
- Strengthen relationships between municipalities, and First Nations and Métis communities; and
- Encourage regional planning.

The amendments also incorporate the topics of climate resilience, including mitigation and adaptation; economic growth; and community health and well-being.

See the **Changes Guide** for more information. Over the coming months, the Ministry of Government Relations will also update the **Planning Handbook**, which is the companion document to the regulations.

In 2019, Municipalities of Saskatchewan members passed a resolution indicating that municipalities advocate the provincial government to immediately begin developing a comprehensive seniors' strategy. All that has happened since that time emphasizes the need for a plan that gives direction for future provincial government policies and financial investment.

The Saskatchewan Seniors Mechanism (SSM) has continued to work towards promoting awareness and interest in its research-backed campaign for support for older adults (55+) in all communities (developing a Seniors Strategy).
