# Saskatchewan Leads Canada in June Building Permits

Statistics Canada has released the June 2021 numbers on the value of building permits, and Saskatchewan saw an increase of 27.6 per cent from May 2021 (seasonally-adjusted). This was the highest percentage increase among the provinces; nationally, permits were up 6.9 per cent.

The total value of building permits in Saskatchewan was \$160 million.

Building permits were also up 76.6 per cent year-over-year compared to June 2020, the second highest percentage increase in the nation.

Non-residential building permits (seasonally-adjusted) were up 31.1 per cent over May 2021, and residential permits increased by 24.4 per cent in this period; year-over-year they were up 87.9 per cent and 67.8 per cent, respectively.



### Over \$3.7 Million for Paratransit Services in Municipalities

More than \$3.7 million in funding has been announced for the Transit Assistance for People with Disabilities program (TAPD). TAPD is an annual provincial grant program available to Saskatchewan municipalities who offer paratransit services.

In total, 69 municipalities - 14 cities and 55 towns - across the province will receive funds through TAPD in the 2021-22 fiscal year. See the <u>list of grant recipients</u>.

Accessible and safe transportation is also identified as one of six priority areas in the <u>Saskatchewan Disability</u> <u>Strategy</u>. The TAPD program directly supports this priority by helping Saskatchewan municipalities provide safe and available public paratransit service to residents across the province.

Now until **September 30**, citizens can provide input on *The Radiation Health and Safety Regulations*, 2005.

The review of the legislation focuses on key aspects of radiation health and safety including dose monitoring, certification of equipment, safety and preventative maintenance inspections, and other

#### Vaccination Roll-Out Transitioning to Outreach

The Saskatchewan Health Authority (SHA) has transitioned to vaccination outreach. On August 8, the SHA discontinued drive-thru and appointments booked through their online system and 1-833-SASKVAX, shifting to walk-in clinics in public venues throughout the province, including planned summer events, post-secondary campuses, retail locations, community centres, and more.

Participating Saskatchewan pharmacies will continue to provide COVID-19 vaccinations by appointment.

### Protecting Children Under 12 from COVID-19

Currently there are no COVID-19 vaccines approved for children under age 12 in Canada. Children can contract, transmit, and become ill with COVID-19, though the risk of serious health outcomes is lower than older populations.

The Saskatchewan Health Authority has created a question and answer about protecting children under age 12 from COVID-19. Questions include the steps caregivers should take to

keep children safe, if children older than two years of age should continue to wear masks, and more.
