# Transforming Wastewater Sludge into Environmentally Friendly Products

Buffalo Pound Lake is both Moose Jaw and Regina's primary water source, providing potable and drinkable water to 230 000 residents after treatment at the Buffalo Pound Treatment Corporation. Water treatment is a long and necessary process, but it creates waste in the form of sludge; this is a problem that we haven't had a sustainable solution to until recently.




University of Regina associate professor of environmental systems engineering, Dr. Jinkai Xue, has teamed up with Buffalo Pound Treatment Corporation and found a potential solution. Each year, the corporation spends over 1 million dollars to dry the wastewater sludge and move it to a landfill. It's a method that is neither environmentally friendly nor cost effective.


Instead, Dr. Xue's research offers a better method: convert the sludge into a ceramic like material called ceramsite, which can have multiple chemical features such as being porous and having high material strength. Most notable about this material is that it can be used to absorb 90 percent of the phosphorous in our water bodies, preventing blue-green algae blooms, a sustainable time and money saver. Even better, the used ceramsite can later be sold as fertilizer for soil, thus starting a sustainable cycle. This exciting new research has the potential to revolutionize our wastewater and benefit many municipalities beyond Moose Jaw and Regina.

#### Fire Underwriters Survey Webinar

The Insurance Brokers Association of Saskatchewan (IBAS) is working with Fire Underwriters Survey (FUS) to support Saskatchewan municipal governments in updating their FUS data.

FUS is a national organization that provides data on public fire protection for fire insurance statistical work and underwriting purposes of subscribing insurance





This summer, **IBAS** is hosting free webinars to introduce FUS to Saskatchewan's municipal governments, walking you through the online portal and explaining how to enter your data.

We recommend that your **administrator and fire chief attend**, if possible. The webinar will be held via Zoom on on **August 17th from 12:30 to 1:30 p.m**.

# Apply for the Flood Damage Reduction Program

The Water Security Agency (WSA) is offering a cost-sharing rebate to help communities implement proactive flood damage prevention and reduction measures. The Flood Damage Reduction Program (FDRP) supports cities, towns, villages and hamlets at risk of recurrent flood damage.



FDRP is part of an overall \$500,000 investment that transitions from the Emergency Flood Damage Reduction Program (EFDRP) announced in April, that deals only with imminent flood risk, to a more proactive longer-term program. Any funds that have not been spent under EFDRP transitions to FDRP.

Applications will be accepted until October 1, 2023. The project work will need to be completed by March 31, 2024.



WSA will accept applications for:

- hydrologic and/or hydraulic investigations to develop risk assessments;
- flood mapping projects;
- mitigation planning, where municipalities develop emergency flood response plans or potential flood damage prevention construction designs; and,
- construction of permanent flood protection works.

Eligible projects will be cost-shared on a 50/50 basis between WSA and the proponent, up to \$100,000 per project.

### **ADVOCACY UPDATES**

#### Mental Health and Addictions Advocacy

While it may be summer, SUMA continues to make progress on a number of important advocacy files. Following our media release relating to the homelessness crisis, our advocacy advisors have been working hard to get a fuller picture of the issue by speaking with community organizations who are on the frontlines.

On the public safety and health front, we continue to move forward on the ask the Provincial Government to review and modernize *The Police Act, 1990*. We remain committed to advocating the Federal Government to pick up the costs for Body Worn Cameras for RCMP



**officers** beyond the implementation phase and have recently sent correspondence to the the Minister responsible for Public Safety on the matter. We have also identified this as an area for collaboration with the Federation of Canadian Municipalities.

As always, small urban healthcare, including doctor, nurse, and paramedic retention and recruiting, and ambulatory services, remains an important issue that we continue to press for action on. SUMA staff recently met with representatives from the Saskatchewan Health Authority to discuss recruitment issues.
