



# Saskatchewan Announces Carbon Capture and Utilization Storage Priorities

The Government of Saskatchewan has announced its key priorities to advance private sector investment in carbon capture utilization and storage (CCUS).

The announcement was made today by Energy and Resources Minister Bronwyn Eyre.

The provincial government anticipates that CCUS projects will attract provincial investment of more than \$2 billion and sequester more than two million tonnes of CO2 annually.

Saskatchewan is launching a pilot program in a small selection of schools to provide COVID-19 self-testing rapid antigen kits to families with students under age 12. This group is currently not eligible to be vaccinated.

# COVID-19 Vaccine Auto-Notification Voice Call Messages Coming to Saskatchewan

As COVID-19 cases in Saskatchewan rise again, the Saskatchewan Health Authority (SHA), Indigenous Services Canada, Northern InterTribal Health Authority, and First Nations Partners have come together to launch the first phase of a vaccine auto-notification system on **September 8** in Northern Saskatchewan.

The phased project will use voice call messages to send notifications to Northern Saskatchewan residents, aged 12 years old and over. These notifications help to ensure everyone is aware that COVID-19 vaccines are available to them so they can choose to become protected against exposure of COVID variants and protect themselves, their families, and those around them. Additional phases will be considered once the first phase is evaluated.

# SHA Adopting Modified Approach to Case and Contact Tracing

The Saskatchewan Health Authority (SHA) is adopting a modified approach to case and contact investigations. As a result, COVID-19 positive persons will be supported to notify their own close contacts.

SHA Public Health will:

- Quickly notify individuals testing positive for COVID-19 and provide isolation education.
- Educate individuals testing positive for COVID-19 on who is a close contact and what information to provide to their close contacts.
- Continue to identify persons testing positive in healthcare settings, vulnerable populations, long term care and other congregate living settings to prioritize investigations in these settings so that outbreak prevention and control measures can be put into action quickly.

The SHA and Ministry of Health are working together to review the protocols around school case management and contact tracing.
