Take SUMA's Municipal Election Date Survey

The 2024 municipal election is currently scheduled for November 13, 2024. The provincial election is scheduled for October 28, 2024. Saskatchewan's Chief Electoral Officer has suggested the <u>municipal</u> <u>election date be changed</u> to avoid voter confusion as experienced during the elections in 2020.

SUMA is asking all municipalities to take a short, one question survey and tell us which option is best for Saskatchewan's municipal elections.

Ask Your Mask and Vaccine Questions at SUMA's Next Webinar

Effective October 1, a proof of vaccination or negative COVID-19 test will be required to enter spaces like event and entertainment venues, fitness centres, and indoor dining. All Government of Saskatchewan ministry, crown, and agency employees will also be required to show proof of vaccination or a negative COVID-19 test.




Legislative Framework Training Later this Month

COVID-19 UPDATE

Mandatory Masking In Effect

Non-medical masks are currently required in all indoor public spaces in the province.

An interim public health order requiring masking came into effect September 17. The order is targeted to be lifted in late October at which time a full proof of vaccination or negative test requirement will have been fully implemented for approximately three weeks.

Youth age 18 and under are not required to wear masks while they are actively engaged in indoor athletic activities. However, masking in venues hosting youth athletics remain required for general entry and exit into the facility for athletes and spectators.



Proof of Vaccination Required October 1

The Government of Saskatchewan has announced that starting October 1, members of the public will be required to show proof of vaccination, or a negative COVID-19 test, to dine indoors and enter spaces like event and entertainment venues and fitness centres.

Employees of Saskatchewan's ministries, crowns, and agencies will also be required to show proof of vaccination or a negative COVID-19 test.
