# Adoption of the 2020 National Fire Code of Canada

Periodically, under The Fire Safety Act, The National Fire code is adopted to update policies and regulations around fire. Before adoption, each code is analyzed to determine what amendments need to be made.



In 2022 and 2023, the Saskatchewan Public Safety Agency (SPSA) consulted various public safety and industry partners on The National Fire Code (NFC), The Fire Safety Act (TFSA), and The Fire Safety Regulations (TFSR), in an effort to improve fire safety.

During these discussions the SPSA announced the decision to postpone adoption of the 2020 NFC until January 2024. This decision was made to align with the proposed adoption date of the 2020 National Building Code of Canada; it also allowed Fire Code users more time to review changes.

Since then, the SPSA has moved forward and proposed the complete adoption of the 2020 NFC. However the existing amendments related to the Alternative Family Care Homes are intended to be retained. Notable changes between the 2015 NFC and the 2020 NFC involve the following:

- 1. Requirements for Building of Encapsulated Mass Timber Construction (Parts 2 and 5)
- 2. Emergency Planning (Part 2)
- 3. Large Farm Buildings (Parts 2 and 4)
- 4. Water-miscible Liquid Mixtures (Part 4)

These areas have undergone significant modifications to address specific fire safety considerations outlined in the 2020 NFC and have been through the federal public consultation phase as well. If you have questions, you can reach Fire Marshal Wayne Rodger at wayne.rodger@gov.sk.ca.

# The Saskatchewan Government Cabinet Shuffle and Our Advocacy Efforts

On August 29, the Saskatchewan Government announced a cabinet shuffle. We congratulate all ministers, new, reassigned and returning, on their appointments.

As an advocacy organization, **cabinet shuffles can pose a challenge as they have the potential to break up momentum on files.** However, we look forward to meeting with new Ministers once they have settled into



their roles to continue our work.

There are several major issues underway. In the Public Safety and Health portfolio, we continue to work on a renewal of The Police Act. **Prior to the shuffle, Minister Tell had been working with SUMA to modernize the Act. We will continue this work with Minister Merriman in his new position.** 

As Minister Merriman switches his focus to corrections, policing, and public safety, his expertise on the Health portfolio will be missed, but we look forward to continued cooperation with new Minister of Health, Everett Hindley. We also welcome discussions with Tim McLeod as the new Minister of Mental Health and Addictions, Seniors and Rural and Remote Health.

Mental Health and Addictions will continue to be a cornerstone issue for SUMA and as always we will keep pushing forth with your resolutions.
