Impacted Sites Fund

Established in 2019 by the Ministry of Environment, the Impacted Sites Fund provides financial support to municipal governments to assess and clean up sites so they can be used for future development. Some example of impacted sites include ones abandoned to municipalities in tax arrears or those that have contaminated soil and water from former gas stations or laundromats. The program is funded from fines collected when a violation occurs under The Environmental Management and Protection Act, 2010.

Municipalities and municipal partnerships can apply for funding by filling out an application form and submitting it through the Ministry of Environment's **Online Portal**. Applicants may be eligible for 100 per cent funding to complete environmental site assessments, or between 25 and 100 per cent funding for the clean-up, depending on the level of risk associated with the impacts.




The Town of Shaunavon was the first successful applicant and has received \$71,974 to date to complete environmental site assessments at an abandoned car dealership property.

Johnson Shoyama Graduate School of Public Policy's Annual Houston Lecture

Learn More About the Targeted Sector Support Program

Municipalities have until **November 30** to apply for project funding through the Targeted Sector Support Initiative (TSS), a cost-shared grant program.

The TSS initiative provides support to municipalities **partnering on projects focused on inter-community collaboration**, **help build capacity and promote good governance**. Funding streams include **capacity building**, **regional co-operation and municipal transition**, **and relationship building and dispute resolution**. Successful projects are eligible to receive **75 per cent of eligible costs** to the maximum amount of \$100,000. Project partners are responsible for the remaining 25 per cent of the eligible costs.

Previously approved projects include training to enhance the governance skills of municipal officials; developing regional emergency plans; undertaking a municipal district feasibility study; and land use analysis maps.

MMSW What We Heard Report Now Available

MMSW has released its What We Heard consultation summary report.

The What We Heard report provides a summary of consultation activities Multi-Material Stewardship Western (MMSW) undertook regarding the draft Program Plan, and the resulting feedback from stakeholders. The draft program plan is in response to The Household Packaging and Paper Stewardship Program Regulations, 2023, which came into effect on March 31.

MMSW submitted the revised plan to the Ministry of Environment on September 26 for review. More details are available on the MMSW <u>website</u>.

ADVOCACY UPDATES

Building Relationships to Advance Advocacy

SUMA's Regional Meetings, taking place this week and next, will include **third round of consultations on our governance structure**. After these consultations have taken place, we plan to put our governance structure to a **vote during the 2024 Annual General Meeting**.

Regional Meetings are an important time to connect with other municipalities and share thoughts on ideas and issues, and SUMA is looking forward to connecting with members from all of our regions.

Recently, our President, Randy Goulden, and CEO, Jean-Marc Nadeau, travelled to Edmonton to support our sister organization, Alberta Municipalities, during their annual convention. **Collaboration is essential to advocating at the federal level**, so building coalitions with our sister organizations is critical to success.

SUMA's Board of Directors met in Saskatoon on September 22 for our quarterly meeting.

As we near the end of the year, SUMA looks forward to continued advocacy developments, and will keep working on issues important to our hometowns.

Mental Health, Addictions, and Housing Advocacy Update

Mental health and addictions remains SUMA's cornerstone advocacy issue. As such, we were pleased with the Government of Saskatchewan's recent announcement of an <u>Action Plan for Mental Health and Addictions</u>.



According to the release, the intent of the Action Plan is to create **500 new addictions treatment spaces and a**

central intake system that makes care more accessible and responsive. Work will begin immediately with a promise of \$49.4 invested in total by the fifth year of the plan. The plan also commits to a cross-governmental approach, involving collaborative initiatives between the ministries of Health, Social Services, Education and Corrections, Policing, and Public Safety.

We commend the province and acknowledge the investment it has made in taking this step towards sustainable change.

That said, we feel it prudent to acknowledge that **without livable social support and changes to direct payment for SIS and SAID, the homelessness, mental health and addictions crisis will continue**. We are hopeful that the newly announced central intake system will incorporate in person consultations and applications. There is clear evidence the central call centre application process for SIS and SAID has proven disastrous for our most vulnerable community members.

We are hopeful this new announcement will **aim at addressing barriers to accessing services**, **such as funding of community regular community ID clinics**.

155 new supportive housing spaces are a great start and we urge the government to consider how imperative it is to have these spaces as low barrier as possible, aiming to keep families together whenever possible.

In conclusion, we wish to **acknowledge and commend this step** and we look forward to continuing to work with the Government and many other stakeholders to make progress on this file.

- Regional cooperation (a joint initiative involving at least one rural and one urban municipality)


