The program, designed to help with the costs associated with running locally-owned rinks, provides communities, First Nations, schools, and non-profits with an annual grant of \$2,500 per indoor ice surface.

The program is administered by the Saskatchewan Parks and Recreation Association on behalf of the Government of Saskatchewan.

# New Pricing for Shipping Labels

Effective **November 15**, the **price of shipping labels** through SUMA's shipping labels program **is increasing**.

The pricing change reflects an increase in Canada Post's fuel surcharge. Canada Post has increased their fuel surcharge to 14 per cent, up from 5 per cent in October 2020.

New shipping label pricing: XPressPost 1.36K - \$363.80 XPressPost 5K - \$488.78.

Even with the new prices, you will continue to save with SUMA's shipping label program. Purchasing shipping labels through SUMA's program **saves your municipality approximately 40 per cent** when compared to the cost of purchasing shipping labels directly from Canada Post.

As of November 15, SUMA will also no longer offer priority post mailing labels. More information about SUMA's shipping labels program can be found on the <u>SUMA</u> <u>website</u>.

# Get Ready to Fill Out The Municipal Revenue Sharing Declaration of Eligibility

Each year, municipalities must report their compliance with eligibility requirements to receive their Municipal Revenue Sharing (MRS) Grant by completing an online Declaration of Eligibility form.

The Ministry of Government Relations will be emailing the unique link and password for the online MRS Declaration of Eligibility form to each municipality on **November 15**. If you do not receive the email on November 15, be sure to check your spam/junk folder. Still can't find the email? Email <u>grcompliance@gov.sk.ca</u>.

The Declaration of Eligibility requires a resolution from council and the deadline to submit the declaration is **January 31, 2022.** Municipalities will want to include the Declaration of Eligibility on the November, December, or January council meeting agenda to ensure the resolution from council is made before the deadline. A sample resolution can be found in the **Declaration of Eligibility Guide**.

The Saskatchewan Public Safety Agency (SPSA) is conducting a review of Saskatchewan's drought risk, which has a view toward sharing insights and proposing options for managing current and future drought impacts. This review is being conducted in partnership with members from the Ministry of Agriculture, Ministry of Government Relations, and the Water Security Agency. This project has two main objectives: 1) Study the impact of drought on Saskatchewan communities; and 2) Propose options for mitigating and responding to those impacts.

# Apply for the Inclusive Community Initiatives Fund

The Federation of Canadian Municipalities (FCM) has launched the first round of applications for the Inclusive Community Initiatives fund. A total of 20 to 25 projects of **\$5,000 to \$10,000** each will be funded through two rounds of applications.

FCM is accepting applications for projects that are aimed at strengthening the capacity of communities to support women, particularly those who are underrepresented, to run for, assume, and/or remain in leadership positions in local government.

The Inclusive Community Initiatives is through the Canadian Women in Local Leadership project, a three-year project implemented to build on the success of FCM's Toward Parity in Municipal Politics and Diverse Voices. The project aims to address the systemic barriers that women face running for municipal office, while also improving the context and environment once elected to ensure their full participation once in office.

## Community Investment Funding

The CanExport Community Investments program is accepting applications from Canadian communities seeking financial support for their foreign direct investment initiatives.

The program is designed to support Canadian communities seeking to improve their capacity to attract, retain, and expand foreign direct investment to create jobs, support innovations, and increase exports.

For the purpose of the program, foreign direct investment refers to international businesses establishing or expanding operations in Canada. The program does not fund initiatives related to mergers and acquisitions, investments from other parts of Canada, trade, or export.

This program provides reimbursement of up to 50 per cent of eligible expenses.

# SUMA Meets with Minister of Corrections, Policing, and Public Safety

On October 7, SUMA's Executive Committee met with the Honourable Christine Tell, Minister of Corrections, Policing, and Public Safety, to discuss municipal concerns. During the meeting, SUMA and Minister Tell discussed:

- the need to re-write The Police Act;
- RCMP policing costs;
- crime and gangs in smaller communities; and
- changes to bylaw enforcement.

Regarding policing costs, SUMA's Executive Committee voiced concerns with the retroactive salary increases for RCMP officers. We know that having these costs downloaded to municipalities, on top of the agreed upon salary increase, will put many municipalities in a dire financial situation. We've asked the provincial government to support our position with their federal counterparts. To assist our advocacy, we launched a letter writing campaign, with a **template letter that municipalities can send** to the Minister of Public Safety. During the October 7 meeting, Minister Tell and her staff committed to not only advocating for the federal government to absorb the cost of the retroactive salary adjustments, but to take the matter to dispute resolution if necessary.

Minister Tell also agreed that *The Police Act* needs to be re-written, and she supports alternative options for municipalities to enforce and prosecute/adjudicate bylaws. During the meeting, she also noted that the throne speech will introduce several measures to address crime occurring in small urban and rural municipalities.

# Tips for Managing Your Convention 2022 Hotel Reservations

Last month we opened hotel reservations for our 2022 Convention and Tradeshow. We are once again using our hotel booking system, **Resiada**, which allows you to view prices for all Convention hotels, see where they are located, check their availability, and book rooms. After booking, until you receive your hotel confirmation numbers just before Convention, you can also use Resiada to make changes to your reservations.

All reservation information is currently contained in Resiada. Therefore, the hotels are unable to make changes to any reservations at this time. **To make changes**, or to cancel a room, simply **click the "Edit Reservations Now" button in the Group Reservation Acknowledgment email** sent when you first made reservations. Can't find the email? Let us know and we will resend it.

#### Introducing the Waitlist

If there is a hotel that you are interested in booking, but it already sold out, you can **join the waitlist** for that hotel and **be automatically updated if rooms become available**.

#### Want to Stay Longer?

We have secured additional rooms at select Convention 2022 hotels for those looking to arrive on April 2 or stay until April 7. You can see what hotels have availability those days by visiting Resiada. If you have existing reservations, click the "Edit Reservations Now" button in your Group Reservation Acknowledgment email to see if extra nights have been added at your hotel.

# **COVID-19 UPDATE**

## **COVID-19 Vaccine Policy Templates for Municipalities**

Since the provincial government introduced proof of vaccination or negative COVID-19 test requirements for all Government of Saskatchewan employees and for public access to select businesses and event venues, SUMA has heard from members requesting templates for municipal proof of COVID-19 vaccination policies.

SUMA has created **two policy templates for SUMA municipalities** interested in introducing proof of COVID-19 vaccination requirements for employees and visitors.

#### Proof of Vaccination Requirements Expanded

A new Public Health Order has come into effect, adding some businesses and retail outlets to the list of venues requiring proof of vaccination or negative test for public access.

Proof of vaccination or a negative test is required at point of entry to access:

- Seated dining in all restaurants including fast food restaurants;
- Liquor manufacturers conducting retail liquor sales; and
- Liquor stores with an integrated permit that also hold a liquor restaurant or tavern permit.
