Through the initiative, communities with populations of less than 150 people have the chance to win complimentary

registration for two delegates to our annual convention.

For 2024, SUMA is offering three municipalities with populations of less than 150 people the chance to send two representatives to Convention 2024 happening April 14-17 in Regina.

Please note: Populations are based on 2021 census data. Municipalities must be a SUMA member in good standing to be eligible. A municipality can only be awarded once per election term.

Applications will be reviewed to ensure eligibility. All eligible applications will be entered into a random draw and the three successful municipalities will be notified by **January 11**.

Election Supplies and Ballot Ordering Processes

Since the 1997 election, SUMA has been offering election forms, supplies and ballot printing to our members. It provides a one-stop shop for all SUMA members with the assurance that supplies will be upto-date, and a staff member available to answer questions or refer them to the appropriate contacts at Government Relations.



Recently there have been some updates to our

ordering processes. SUMA members can still order ballots and supplies, but please make sure to order ballots a minimum of 15 business days prior to advance poll date to ensure ballots arrive in time. The same policy applies for SARM members, but please note members of SARM can only order supplies from SUMA and not ballots.

Member Advantages

- Substantial cost savings, based on bulk purchasing of supplies and bulk processing of ballots
- Election forms as prescribed by *The Local Government Election Act* accurately reproduced ready for use on election day
- Forms and supplies shipped using the most cost effective method for each individual municipality (within one to two business days of order receipt)
- When the order is received by the SUMA office within 15 business days prior to the advance poll date, guaranteed processing of ballot orders to meet the limited turn-around time between close of nominations, advance poll, and election dates. Orders received less than 15 business days prior to the advance poll date cannot be guaranteed.

Grants Available for Facilitating Independence

Facilitating Independence is a process that focuses on supporting older adults to live as independently as they wish to, in their location of choice. The goal is to provide supportive services and options which allow older adults to live a meaningful and freely chosen life, in their home and community. The intent of the Facilitating Independence Grant funding is to experiment and support trial projects to learn more about



innovative, sustainable models that will enable older adults to age well at home. Learnings from the projects may be valuable to other communities in the province.

Grant funding was provided to 13 organizations in 2023. Based on the success of the first Facilitating Independence grant program in 2023, the Saskatchewan Seniors Mechanism (SSM) has another approximately \$200K in 2024 for one-time funding for micro-grants/seed money to organizations that serve older adults, community groups, or other interested organizations to develop/pilot new approaches for providing supportive services to older adults. Amendments to The Workers' Compensation (Extending Firefighter Coverage) Amendment Act, 2023

The Government of Saskatchewan introduced amendments to *The Workers' Compensation (Extending Firefighter Coverage) Amendment Act, 2023.*

The amendments introduced include changes to the following: the definition of the term worker; privacy provisions; appeal tribunal decisions; coverage of expenses associated with transporting a deceased worker's body; compensation to a worker's dependent children; medical review panel process; permanent functional impairment award; independence allowance amount; and presumptive occupational disease coverage.

ADVOCACY UPDATE

Throne Speech Acknowledges Mental Health, Addictions and Housing Issues

The Government of Saskatchewan's recent Throne Speech focused on homelessness, mental health, and addictions. SUMA is pleased to see the province giving attention to these issues. We have continually advocated for more action on the homelessness crisis and the shortage of healthcare professionals in our province. Many of the coming promised changes and implementations are a direct result of our advocacy.



The implementation of the Provincial Approach to Homelessness is a positive step. We are also pleased to hear about expanded support for second stage housing to protect those suffering from interpersonal violence, and the previously announced complex needs emergency shelter spaces as these projects will have a positive impact not only on the homelessness crisis but also mental health and addictions within our province. We welcome all these developments, but encourage the Government to take this a step further and amend the SIS and SAID programs to address continuing issues experienced by Saskatchewan's most vulnerable population.

The Action Plan for Mental Health and Addictions is also a direct result of advocacy from SUMA and many other partners and NGOs throughout the province, and we are pleased to recognize the 500 new addictions treatment spaces across the province, as well as expanded mental health services for children and youth. We again encourage the Government to continue this

positive momentum by **considering safe consumption sites for those who are not ready for treatment.** For those who are, we advocate for **changes to the current 28-day treatment model**, which research shows is lacking in its efficacy, and **more resources for aftercare**.

Other positive news out of the Throne Speech are the **nursing loan forgiveness program** and the continued work on the Health Human Resources Action Plan. SUMA has been advocating for this government to address the **recruitment and retention of healthcare professionals, particularly in small urban centres,** for several years and we will continue to push for more action on this important file.
