More than \$1 Million Invested in 19 Municipal Projects

The Government of Saskatchewan is investing more than \$1 million in municipal projects through the **Targeted Sector Support (TSS) Initiative**.

The TSS Initiative supports joint municipal projects to assist in supporting more efficient and effective municipal service delivery through increased regional cooperation, capacity building, municipal corporate transition, relationship building, and dispute resolution. Funding is provided through cost-shared grants, covering up to 75 per cent of eligible project costs, up to \$100,000.

Examples of approved projects include:

- Lagoon expansion planning between the Town of Radisson and municipal partner the Battlefords Tribal Council.
- A training session for municipal bylaw enforcement between the Village of Kennedy and 17 municipal partners.
- Creating an updated emergency response plan with the R.M. of Argyle and two municipal partners.

SUMA administers the program and funding on behalf the TSS Steering Committee. The TSS Steering Committee consists of representatives from SUMA, the Saskatchewan Association of Rural Municipalities (SARM), the Saskatchewan Association of Northern Communities (New North) and the Ministry of Government Relations.

"SUMA is grateful for the Government of Saskatchewan's continued investment in the Targeted Sector Support Initiative," SUMA President Randy Goulden said. "As development and service demands increase, this program plays a key role in helping municipalities work together to meet the growing needs of our communities. We are proud to support the TSS program and celebrate the innovative municipal projects it makes possible."

ADVOCACY UPDATE

SUMA Gathers with the Government of Saskatchewan and the Official Opposition

SUMA is participating in the Saskatchewan Party's Northern Golf Classic tomorrow at Elk Ridge Resort, where we're looking forward to meeting with Saskatchewan Party Caucus Members and Cabinet Ministers.

Last week, SUMA joined Policy Discussion tables hosted by the Saskatchewan New Democrats in Prince Albert, where we discussed economy, crime, and safety with NDP MLAs and local leadership.

Water Security Agency: Outcome-Based Compliance

On August 6, SUMA met with the Water Security Agency to discuss an outcome-based compliance framework currently under development. The framework aims to improve service excellence in water management and promote sustainable water use, including drinking water, aquatic habitat protection, liquid domestic waste hauling, aquatic nuisance control, and water allocation. The outcome-based compliance framework will include standardized pathways with compliance actions that are proportionate to risk. The framework also deploys an adaptive strategy to ensure compliance is effective in achieving desired outcomes.

Low Carbon Cities Canada (LC3)

Last week, SUMA met with Low Carbon Cities Canada (LC3) to discuss how an LC3 Board could be set up in Saskatchewan to potentially provide funding for environmentally conscious projects.

E-Justice Platform

On July 31, SUMA met with the Mayor of Elbow and former Deputy Minister of Justice and Attorney General, Glen Gardner, to learn more about the e-Justice platform that the Ministry of Justice has developed (but not yet implemented). E-Justice is an online dispute resolution platform that could potentially benefit urban municipalities through supporting bylaw enforcement, offering restorative justice approaches, and providing access to community services related to civil disputes and family law.

This approach is well-aligned with SUMA's advocacy focused on understanding and addressing root causes of justice issues, particularly related to preventative measures around homelessness, mental health, and addictions.

Saskatchewan Ombudsman

On July 29, SUMA visited the Saskatchewan Ombudsman to discuss educational opportunities for SUMA members and how the Ombudsman can assist and mediate.

Communities in Transition

SUMA met with Government Relations, SARM, and other partners to discuss Communities in Transition and the ongoing viability of smaller communities in Saskatchewan on July 24.

EMS and Paramedic Services

On July 21, SUMA met with EMS and Paramedic Services to discuss current concerns around recruitment and retention for EMS personnel.

Local Leadership for Climate Adaptation (LLCA)

The Federation of Canadian Municipalities, through its Green Municipal Fund, has launched a new intake for the **Local Leadership for Climate Adaptation (LLCA)** funding program that supports the development of municipal climate adaptation plans, climate-focused asset management strategies, community-wide climate risk assessments, and capacity-building initiatives.

In the past year, **Eco-West Canada (EWC)** has successfully helped several municipalities in securing funding under this program and is now extending its support to communities in Saskatchewan. As a **partner of the Saskatchewan Urban Municipalities Association (SUMA) and its new Municipal Eco-Action Centre**, EWC is well-positioned to assist Saskatchewan municipalities in navigating this opportunity.

To get started, municipalities will need to complete FCM's **Climate-Ready Communities Assessment Tool** — an important first step in the application process. EWC can help guide your municipality through this assessment and the full funding application process afterward.

The deadline to submit applications to the LLCA program is **September 16, 2025**.

Homelessness Reduction Innovation Fund

Call for Projects: Wildfire Resilient Buildings

With wildfire risks on the rise across Canada, the Climate Ready Infrastructure Service (CRIS) has launched a new stream of support to help local governments and Indigenous communities make public buildings safer and more resilient:

- Communities under 30,000 can now access up to \$20,000 in expert support, fully funded and coordinated by the CRIS team.
- Support includes tailored advice on fire-resilient design, materials, and indoor air quality for design or retrofit projects approved in a capital or work plan.
- Eligible buildings include community centres, libraries, civic centres, water/wastewater facilities, fire halls, and more submit your public infrastructure project!

The program output is a customized **Technical Options Report** with strategies and high-level cost estimates to help you determine the best-fitting solutions to incorporate wildfire resilience into the design or retrofit your infrastructure.

Survey for Municipal Leadership and Staff
