Applications are being accepted for Targeted Sector Support (TSS) Initiative funding from now until **February 1, 2022**.

The TSS Initiative provides cost-shared grants for projects undertaken by two or more Saskatchewan communities which lead to:

- improved inter-community relationships and co-operation
- enhanced governance
- increased administrative capacity
- assistance for municipal transitions

TSS funding is a portion of Municipal Revenue Sharing used to encourage intercommunity collaboration and good governance in all Saskatchewan municipalities.

Community Safety Officer Program

Looking to promote safety and enhance bylaw compliance in your hometown? Has your municipality considered a Community Safety Officer (CSO)?

CSOs are municipal employees who carry out high priority, low risk enforcement of bylaws and select provincial statutes. A CSO can provide a uniformed presence in your hometown,

liaise with schools and community groups, and target enforcement of municipal bylaws and traffic laws.

Help Update the Railway Proximity Guidelines

The Proximity Guidelines were established in 2003 to build common approaches for the prevention and resolution of issues that arise when people live and work near railway operations. The Federation of Canadian Municipalities (FCM) and the Railway Association of Canada (RAC) promote the guidelines through the Proximity Initiative.

The guidelines are intended for use by municipalities and provincial governments, municipal staff, railways, developers, and property owners when new developments in proximity to railway operations are proposed.

As the Proximity Guidelines have been available for municipalities to use for nearly 20 years, FCM is reaching out to communities across the country to gather important data that will highlight areas that need to be emphasized as they prepare to update the Guidelines by 2023.

Join the Ministry of Environment's Composting Focus Group

The Saskatchewan Ministry of Environment is looking for members for a focus group to develop the Composting Chapter of the <u>Saskatchewan Environmental Code</u>.

The Saskatchewan Solid Waste Management Strategy committed to developing new code chapters for transfer stations and composting facilities, to be implemented by 2022-23.

The Ministry of Environment is looking to bring together a focus group to provide advice and guidance from unique perspectives. Members will be selected based on the needs of the focus group and the individual's expertise, while ensuring a diverse number of perspectives are represented.

New Pricing for Shipping Labels

Effective **November 15**, the **price of shipping labels** through SUMA's shipping labels program **is increasing**.

The pricing change reflects an increase in Canada Post's fuel surcharge. Canada Post has increased their fuel surcharge to 14 per cent, up from 5 per cent in October • overtime, overtime banks, and vacation entitlements.

New shipping label pricing: XPressPost 1.36K - \$363.80 XPressPost 5K - \$488.78.

Even with the new prices, you will continue to save with SUMA's shipping label program. Purchasing shipping labels through SUMA's program **saves your municipality approximately 40 per cent** when compared to the cost of purchasing shipping labels directly from Canada Post.

Accessibility Legislation Engagement Report Now Available

In the 2019 Speech from the Throne, the Government of Saskatchewan announced that new legislation would be introduced aiming at removing and preventing accessibility barriers for people with disabilities. The new legislation would look at the design of public spaces, information and communications, service animal certification, public sector procurement, public sector employment, and public transportation.

The first phase of engagement for the new legislation ran from February 4 - March 31, 2021 and included surveys and opportunities to ask a question or share a vision for a more accessible Saskatchewan.

WEST Recommendations for a Prosperous Western Canada

In October, the Federation of Canadian Municipalities' Western Economic Solutions Taskforce (WEST) released its final comprehensive report with recommendations to the federal government, as well as a bold vision for a prosperous western Canada.

Since 2019, WEST has brought together urban and rural municipal leaders from Canada's four western provinces to address the economic challenges facing western communities. The final report outlines recommendations that would help support western communities and the industries they rely on.

ADVOCACY UPDATE



SUMA's Takeaways from the Throne Speech: Policing and Mental Health

On October 27, Premier Scott Moe delivered the Speech from the Throne, opening the second session of 29th Legislature. The speech featured plans to expand policing and increase support for people dealing with addictions.

Policing

SUMA was pleased to see the provincial government acknowledge the issues of gang and drug trafficking in Saskatchewan's hometowns through their commitment to increased police presence, particularly the expansion of crime reduction teams. However, SUMA believes that focusing solely on enforcement ignores the opportunity to deal with crime proactively, through education and intervention. We are calling on the Government of Saskatchewan to pair its increase in enforcement with a full review of *The Police Act* and focus on reducing crime through early intervention and programming, via inter-ministry partnerships and working with stakeholders, including municipalities.

Mental Health and Addictions

SUMA has been advocating for increased mental health and addictions support, and we were very pleased to see provincial commitment toward increasing addictions treatment spaces and other supports. However, much more is needed.

SUMA is calling on the Government of Saskatchewan to address this crisis by increasing the number of mental health care providers and supports in the province and working collaboratively with municipalities and non-governmental organizations to identify solutions to ongoing mental health programming issues in Saskatchewan.

COVID-19 UPDATE

Vaccinations for 5 to 11-year-olds

Pfizer-BioNTech is expected to provide the first pediatric COVID-19 vaccine available to children age five to 11 years old and the Government of Saskatchewan has announced that it expects to have enough Pfizer vaccine to provide 100 per cent coverage of first doses.

Pending Health Canada approval, first shipments could arrive in Saskatchewan the week of November 8. Delivery dates are subject to change.

Parents of children five to 11 years of age will be able to seek out immunization at community

pharmacies, SHA and First Nation vaccine clinics.

Protecting Yourself at Work from COVID-19

The Saskatchewan Health Authority is sharing basic health and safety measures that can prevent the spread of COVID-19 among workers.

All workers should:

- Always self-monitor for symptoms;
- Stay home whenever you are sick and seek a COVID-19 test;
- Wear a mask while at work;
- Keep six feet of distance between you and others in the workplace;
- Wash hands often or use hand sanitizer;
- Practice proper sneezing/coughing protocols;
- Maintain a regular schedule to clean and disinfect common areas (doorknobs and shared spaces such as boardrooms and lobby seating areas); and
- Get vaccinated. Vaccination is one of the strongest safety measures people have to protect themselves, co-workers, family, friends, patients and residents.

Workers who test positive for COVID-19 should self-isolate immediately for at least 10 days. Workers not fully vaccinated who have been in close contact with a person with COVID-19 should self-isolate for 14 days as a precaution.
