ADVOCACY UPDATE

Border Crossings

The CBSA (Canadian Border Services Agency) is currently in negotiations with the United States Border Services who are looking at **potential closures and restrictions**, **such reduction in hours of service**, **at various border crossings in the Prairies**. As this change will have a direct effect on ports of entry on the Canadian side, SUMA is in talks with the CBSA. We encourage communities to **petition to oppose reduction of border hours by sending a letter to the CBSA**. You can **use this Petition and Letter of Concern template**.

The CBSA is working with the U.S. to find solutions which will minimize disruptions, and has let SUMA know they will reach out to any effected communities, once they are aware of what changes will occur.


Energy and Resource Opportunities

SUMA CEO, Jean-Marc Nadeau, recently attended the Saskatchewan Energy and Resource Opportunities roundtable, hosted by the Minister of Energy and Natural Resources, Johnathan Wilkinson. During the roundtable, SUMA discussed our leadership in advocating for and pushing policies that promote clean economies through support for emission reduction by 2030, and the establishment of the Municipal Eco-Action Centre. Other topics covered during the roundtable included waste management and the potential for clean fuel production, and opportunities in renewable energy such as wind, solar, SMRs (small modular reactors), which offer promising to diversify the province's energy mix and provide reliable, low-emission baseload power.

2024 Municipal Election Information from SUMA

SUMA began offering election supplies and ballot printing during the 1997 election year. Members can take advantage of our bulk purchasing savings and friendly customer service when preparing for their municipal elections/byelections.

Member Advantages

- Substantial cost savings, based on bulk purchasing of supplies and bulk processing of ballots.
- Supplies shipped using the most cost effective method for each individual municipality (usually within 3-5 business days of order receipt).
- When the order is received by the SUMA office within 15 business days prior to the advance poll date, guaranteed processing of ballot orders to meet the limited turn-around time between close of nominations, advance poll, and election dates. Orders received less than 15 business days prior to the advance poll date cannot be guaranteed.
- Members will be invoiced directly from SUMA.

Municipal Administrator's Corner – Elections Resources

2024 is a general election year for all municipalities in Saskatchewan. Cities, towns, villages, and northern municipalities will hold their general elections on November 13. Election day for resort villages was July 27. (Northern municipalities may move their election date earlier by decision of council).

The Advisory Services and Municipal Relations branch has also updated several resources to assist election officials in carrying out their municipal election. The Election-Byelection Scheduling Tool is a great resource to map out the municipal election process and become familiar with the legislated dates and publishing requirements. The Local Government Election Guide for Saskatchewan municipalities has also been updated and is available to help municipal election officials understand the municipal election process and perform their duties.

Election Resources for Citizens Running for Council

The Ministry of Government Relations, in consultation with the municipal associations (Saskatchewan Association of Rural Municipalities, Saskatchewan Urban Municipalities Association, Urban Municipal Administrators Association of Saskatchewan and Rural Municipal Administrators' Association), developed the following resources geared toward citizens who are thinking about running for municipal council:

- <u>Guide Consider Running for Municipal Council</u> A citizen's guide for candidacy in municipal elections.
- <u>Videos</u> Four pre-recorded videos that break down the guide content into shorter video clips by topic.
- <u>Poster</u> A poster that contains a QR code that the public can use to go to saskatchewan.ca where the new resources are located.

As an administrator, you're encouraged to communicate the availability of these resources to the public by:

- Displaying the poster in the municipal office and/or public spaces frequented by your citizens.
- Printing copies of the poster and/or guide to have available in the office.
- Including the poster on the municipality's website.
- Including information in upcoming mailouts of the municipality.

Changes to the Electronic Equipment Stewardship Regulations

Saskatchewan is considering changes to <u>The Electronic Equipment Stewardship</u> <u>Regulations</u>. The Ministry of Environment completed a review of the regulations in 2023 and wants to understand how proposed changes may impact your municipality, business or organization.

Legal Opinion: R v Greater Sudbury (City)

On November 10, 2023, the Supreme Court of Canada issued its decision in *R v Greater Sudbury* (*City*), which discussed the **current status of municipal liability when it comes to relationships with contractors.** In this case, the City of Sudbury contracted with a construction company to complete road maintenance. Unfortunately, a piece of construction equipment on the job site fatally struck a pedestrian. There were various safety procedures and protocols which were not being followed by the contractor.

Typically, municipalities have been able to limit or avoid liability by "contracting out" of responsibility for following and enforcing construction safety rules and regulations, by designating the contractor as the party ultimately responsible for following such governing legislation (in Ontario, this was the Occupational Health and Safety Act; in Saskatchewan, it would be The Saskatchewan Employment Act and its Occupational Health and Safety Regulations).

However, in this case, the contractor *and* the City of Sudbury were both found liable for the failure to comply with governing health and safety legislation. The Court also found that the defense of due diligence may still exist for municipalities, depending on the facts of the case.

While this case has not yet been applied in Saskatchewan, it is an area of the law to monitor, as it will change how municipalities should conduct business with contractors. In particular, municipalities will likely need to take a more collaborative approach with contracting companies and be more involved in ensuring health and safety procedures and rules are actually being followed, in order to demonstrate the defense of due diligence and protect themselves from liability.

Public Reporting on Municipal Waterworks Due September 1

Municipalities that must submit 2023 public reporting on municipal waterworks to the Ministry of Government Relations must do so by the deadline of September 1. Emails were sent from the Government to each of these municipalities in July 2024, along with a link to the online questionnaire and instructions for filling it out.

Amendments to the three municipal regulations (<u>The Municipalities Regulations</u>, <u>The Cities Regulations</u>, and <u>The Northern Municipalities Regulations</u>) changed some waterworks reporting requirements. Detailed information on the changes can be reviewed in the <u>Fact Sheet on Waterworks Provisions</u>, which was also emailed to municipalities.

Building Code Regulations Revisions

This year, *The Building Code Regulations* were published with revisions to the amendments of the National Building Code of Canada 2020 edition located in the Appendix. These revisions harmonize the intent for application of construction codes throughout Saskatchewan. Amendments to Municipal Acts and Regulations

This spring, with the passing of Bill 153, the following three acts were amended:

- The Cities Act
- The Municipalities Act
- The Northern Municipalities Act, 2010

The amendments improved key areas related to assessment appeals, conducting electronic meetings and improved existing processes to ensure consistency across all three acts. Additional changes were made to the regulations for each Act and were passed through Orders in Council 365/2024, 366/2024 and 367/2024 on July 11, 2024.
