# SUMA Calls for Government Action as China's Tariffs Threaten Saskatchewan's Agricultural Economy

Saskatchewan communities are grappling with significant challenges following China's imposition of a steep 75.8 percent tariff on Canadian canola seed, compounded by a 100% tariff on canola meal and oil introduced earlier in March 2025. These measures have escalated market uncertainties and intensified concerns over the future of trade relations between Canada and China.

Canola generates over \$43 billion in economic activity across Canada and supports an estimated 55,000 jobs in Saskatchewan alone. Many of these jobs are concentrated in urban municipalities, including cities and towns that are home to processing facilities, logistics hubs, grain terminals, and export services essential to moving agricultural products to market. This interconnected infrastructure forms the backbone of Canada's canola export chain.

SUMA is taking action on behalf of canola producers and processors in the province. We have joined with the Agricultural Producers Association of Saskatchewan (APAS) calling on the federal government to take action to ensure fair access to global markets.

Randy Goulden, President of SUMA, remarked, "Agriculture, and agricultural processing, are vital for the well-being of communities in Saskatchewan. They create jobs and generate significant economic benefits for our cities, towns, villages, and northern communities. SUMA is united with APAS in demanding government action on the tariffs and a commitment to expanding global trade opportunities. A flourishing agricultural sector leads to a prosperous Saskatchewan for everyone."

SUMA has also written directly to the Right Honourable Mark Carney, calling on the federal government to:

- Ensure Saskatchewan urban municipalities are included in any future relief, mitigation, or trade stabilization measures
- Support long-term trade diversification and regional economic development strategies

#### **SUMA CEO Builds Cross-Border Partnerships in Montana**

SUMA CEO Jean-Marc Nadeau recently returned from a successful trip to Montana from August 24–28, aimed at strengthening relationships in innovation, trade, and municipal collaboration.

Organized by Brit Fontenot, Bozeman's Director of Economic Development, the visit featured meetings with leaders from Montana's Innovation Center, Bozeman Airport, Big Sky Economic Development Authority, and the Montana League of Cities and Towns. Discussions focused on trade opportunities, municipal partnerships, and potential flight routes between Saskatchewan and Bozeman.

All parties agreed that greater collaboration would be of benefit: **Montana's League of Cities and Towns will attend SUMA's April convention, and SUMA has been invited to their annual gathering.** SUMA was also introduced to officials in North Dakota to expand regional engagement. Other highlights included:

- A podcast invitation to Bozeman Mayor Terry Cunningham for SUMA's MuniCast.
- Advocacy around border reopening with the Montana Department of Commerce.
- Plans for a follow-up meeting in Regina post-convention.

Accommodations were generously sponsored by the Bozeman Chamber of Commerce.

## **Updates from the Saskatchewn Marshals Service**

SUMA President, Randy Goulden, and CEO, Jean-Marc Nadeau, met with Chief Rob Cameron and his deputy chiefs, Richard Lowen and Thomas Sierzycki on September 5 to discuss the rollout of the Saskatchewan Marshals Service.

The Marshals have launched their first regional office in North Battleford, and brought on a complement of 20 officers to-date. Full staffing of the service is not

anticipated until the end of 2026, and additional regional offices will not be brought online until the North Battleford office is fully staffed. Agreements are now in place with other police agencies in Saskatchewan, and the Marshals are responding to incidents, as needed, as part of the overall public safety system in the province.



# **SUMA Calls for Unified Municipal Voice on Federal Infrastructure Investment**

Along with the Saskatchewan Heavy Construction Association, Concrete Saskatchewan, MERIT Contractors Association Saskatchewan, and the Association of Consulting Engineering Companies - Saskatchewan, SUMA sent a letter on July 18 to the Right Honourable Mark Carney and the Honourable Scott Moe calling on the federal and provincial governments to implement a new tri-party infrastructure program so municipalities can provide the critical infrastructure required to drive economic development and community growth in Saskatchewan. We called on both governments to advance trade corridors to better get our products to market, and to engage with municipal leaders across our province to identify additional solutions for supporting jobs and economic development in Saskatchewan.

We are pleased with the **response received from the Government of Saskatchewan**, which affirmed our calls for a tri-party infrastructure program that is long-term, predictable, and responsive to the needs of Saskatchewan communities and for engagement with municipal and industry leaders to advance municipal priorities.

## Canada Housing Infrastructure Fund (CHIF) Fall Intake Announced

On March 10, the Governments of Saskatchewan and Canada announced a 10-year agreement under the Canada Housing Infrastructure Fund (CHIF). The province will receive \$187.9 million through the CHIF program to address housing-enabling infrastructure priorities. In addition, the Government of Saskatchewan is committing approximately \$155 million toward this program. With the new fund, communities across Saskatchewan will be able to build or improve the critical infrastructure related to drinking water, wastewater, stormwater and solid waste in order to support more homes.



On August 21 the Government of Saskatchewan announced the intake opening for applications to CHIF. Applications are due by November 28.

CEO Jean-Marc Nadeau spoke on behalf of SUMA at the announcement event.

"Increasing the housing supply and affordability in our communities depends on our municipalities

having the means to invest in the infrastructure that those houses will connect to," said CEO Nadeau. "We look forward to continuing collaboration between our municipal, provincial, and federal governments to ensure Saskatchewan communities can meet the needs of our growing province now and in the future."

# **Community Airport Partnership Intake for 2026-2027 Now Open**

The **Community Airport Partnership (CAP)** is a program that provides funding for regional, community-owned airports in Saskatchewan.

Funding is available for the rehabilitation, construction and capital improvements of airport infrastructure.

Eligible applicants include regionally focused, community-owned airports. Eligible airports should support:

- Economic development;
- · Access to surrounding communities;
- Air ambulance and medevac operations;
- Commercial operations; and
- Aviation safety.

Typical projects would be pavement rehabilitation, slurry seals, overlays, lighting, GPS approach design, and Automated Weather Observing System (AWOS). Security fencing around an airport may be considered eligible for safety reasons. Consideration will also be given to runway extensions where benefits can be documented for safety, regional economic, and social development reasons.

Applications may be made jointly with other communities, RMs, and businesses in their proposal.
