SUMA asks members to review Code change prior to convention

The Ministry of Environment is initiating a [public review](#) of the [draft Saskatchewan Environmental Code](#). This is the next step in implementing a new results-based approach to environmental regulation. The public review process will end March 16, 2012. [View this link](#) to see the full news release regarding the consultation.

The ministry has scheduled [three public meetings](#) to consult with stakeholders. Currently, municipal focus consultation is scheduled for January 30 in Regina, which conflicts with the 2012 SUMA Convention. SUMA is working with the ministry to host another municipal sector consultation in Saskatoon on February 8, 2012. SUMA delegates are encouraged to attend this later session. Delegates attending the convention can also get information on the Environmental Code from ministry officials during the education sessions on Sunday afternoon.

More information on the February 8 consultation will be provided once the logistics are finalized with the ministry.

SUMA has been a partner in the development of the draft Code and we have been monitoring the progress of the code since 2009. There are several [chapters](#) of the code related to urban governments, including:

Bridge Funding recycling deadlines coming up!

This is a reminder for Bridge Funding participants to submit their second submission, due February 9. The second payment will be based on actual tonnage recycled between July and December, 2011. The per metric tonne (MT) rate has not yet been determined for the second payment, but will be decided by early March, 2012.

Submissions should include July 2011 to December 2011 tonnage receipts showing actual MT of paper and cardboard recycled, and a [receipt submission form](#) detailing recycling information.

A second Declaration Form is not needed, unless one was not included in the first submission.

Municipalities are invited to nominate and vote for their favourite public locations. Prizes will be awarded.

Bylaw Enforcement School soon in session

As of October 2010, the RCMP no longer handle municipal bylaw issues. To fill that gap, Municipal Affairs has asked the Saskatchewan Association of License Inspectors and Bylaw Officials (SALIBO) to undertake training of municipal memberships.
