



President's *Voice*



As 2011 comes to a close, I am extremely pleased with the accomplishments that SUMA has made over the past year. As an association we have successfully represented the interests of urban governments on several important matters. One of the items that is extremely critical to the future of urban governments is the development of a long term sustainable infrastructure program. In partnership with the Ministry of Municipal Affairs, SARM and the cities, SUMA has participated in the preliminary research needed to develop the evidence needed to design such a program. There remains still one large component of this initiative and that is to determine the actual municipal infrastructure gap that exists in Saskatchewan. This is a vital part of the overall project and we will look forward to its completion in the new year.

SUMA has also worked tirelessly on other matters involving affordable housing, recycling, UHCP, changes to the Local Government Election Act and fine revenue distribution. In

addition, we have taken the lead on other initiatives that have played a key role in advancing the interests of urban governments and providing learning opportunities for urban administrators and elected officials. These include the first ever Environmental Forum between SUMA and the Minister of Environment which provided an opportunity for directors to discuss with the minister matters impacting urban governments. A tremendously successful asset management workshop was held with participants from both urban and rural municipalities. This two day session was comprised of experts who addressed the concepts and best practices for asset management. This is just a small sampling of the work we have been focused on.

On the business side of SUMA's operations, we have introduced a couple of new SUMAdvantage partners. Due to change in marketing strategy we have also seen an increase in the inquiries from members for the various services our partners provide. The SUMAdvantage program is an excellent way for members to save valuable dollars for their communities.

In 2012, I am looking forward to many other opportunities. In late January and early February we will be holding the 107th Annual Convention in Regina. As always our convention is a tremendous opportunity for elected officials and municipal staff to network with colleagues and participate in the many learning opportunities.

The association will be looking to achieve additional wins for urban governments on a number of important items in the coming year. Asset management will continue to be promoted by SUMA and the municipal asset management working group which was initiated by SUMA through

various learning opportunities. The board continues to see infrastructure as the most important priority and will work to see the development of the long term program and perhaps the implementation of a short term program to address pressing needs in our member communities. Recycling will also be in the forefront as the provincial plan should be implemented this year and urban governments have a keen interest in this program.

SUMA continues to work on your behalf and is committed to ensuring the interests of urban governments are represented.

In closing, I would like (on behalf of SUMA) to wish a very merry Christmas to those who celebrate that holiday, and a very festive holiday season for those of other faiths. Health, happiness and prosperity to all.

Michael “Pinball” Clemons - driven, committed, unforgettable: *a hero with heart*



Former CFL player and coach to headline SUMA convention At 5'6" and a mere 170 lbs., Michael “Pinball” Clemons’ frame might not cut an intimidating figure – but don’t underestimate him. It’s his heart, his drive and his determination that will make this year’s SUMA convention keynote speaker unforgettable for those in attendance.

Those CFL fans in the audience will recognize Clemons for being one of the league’s best athletes ever, but his work as a speaker is where he truly shines, sharing his message of cohesiveness and putting your heart completely into everything you do.

Born in 1965 in Dunedin, Florida, Clemons has described himself (borrowing a quote from former Canadian Cabinet minister C. D. Howe) as “American by birth, but Canadian by choice”. It’s a choice that Canadians

should be glad he made; Clemons has devoted himself to countless high-profile causes, including the Toronto Argonauts’ “Stop The Violence” campaign, which encourages the active participation of communities, schools and government in educating youth and curbing increasing gun violence; involvement in reading programs; the “Michael Pinball Clemons Foundation” to help disadvantaged youth; and Free the Children, an initiative to build schools and clean water systems in Africa.

“We are no good by ourselves,” Clemons said in a promotional video for Free the Children, adding that our duty as people is to be a “unifying force for the team”. “The first team that we played on – we’re all members of the global community.”

Having truly earned his reputation as an electrifying and energizing speaker, Clemons urges his audiences to tap into their hidden potential, to be the heroes they can be.

“That’s what heroes do – heroes commit themselves to people, and that’s what you can do,” he urges listeners in one of his promo videos.

Breakout sessions offer something for everyone

Tuesday's Breakout Sessions offer targeted information workshops for delegates, no matter what size of municipality they represent. The sessions are split into the following categories: Cities, Northern, Towns and Villages with populations above 500, and Towns and Villages with populations below 500.

Cities

The transformation of infrastructure challenges into opportunities is the theme for the Cities session. Hosted by the City of Regina, Communities of Tomorrow (CT) and the Canada West Foundation (CWF), this portion of the convention programme will focus on innovation in infrastructure. Participants will learn about the 2012 National Infrastructure Summit, which is slated for September 10-12 in Regina. As well, delegates will engage in continued dialogue about employing innovation, technologies and best practices models for infrastructure financing and delivery, using the CWF and CT "Let's TOC" initiative. Session presenters include City of Regina councillor Mike O'Donnell, Casey Vander Ploeg of the Canada West Foundation and John Lee from Communities of Tomorrow.

Northern

The north is a valuable element of Saskatchewan's vibrant economy, and its growing population has the potential to be a great advantage. Northern Saskatchewan covers about half of the province's land mass, but only four per cent of the population lives there. Of these, about two-thirds are under 35 years of age, and nearly 80 per cent are of Aboriginal descent. Rich in

natural resources, sparsely populated, constrained by limited infrastructure, lower education levels and restricted income levels, the north sector of the province faces its own extreme challenges and important opportunities. This session will see representatives from priority provincial ministries meeting with northern leaders to address critical issues for the north, to identify mutually acceptable solutions. Prior to convention, SUMA will be working with New North to determine which ministries should be included, and make sure these groups are well-represented at this session.

Towns & Villages with Populations over 500

The Saskatchewan Physician Recruitment Agency (PRA) will be highlighting the work they have accomplished in the area of physician recruitment and retention. Delegates will have the opportunity to discuss with the PRA what role they can play to recruit and retain doctors in their communities. The PRA (also known as Saskdocs) is a one-stop-shop connecting communities and physicians in Saskatchewan. Established in 2010, the agency is responsible for coordinating and enhancing physician recruitment and retention efforts in the province in close cooperation and partnership with communities, municipalities, doctors, professional associations and local medical trainees. Ed Mantler, PRA's CEO, will provide a detailed presentation to update delegates on: the role of the agency, its mandate and strategies in place to enhance physician recruitment and retention efforts in the province; an overview of current opportunities for municipalities to attract and retain

local medical trainees; and, a detailed review of the future challenges and opportunities we face in recruiting and retaining physicians to Saskatchewan.

Towns & Villages with Populations under 500

With an ageing and shrinking population, shrinking non-residential tax base, and the need to sustain infrastructure and services, many small urban governments are struggling. This session will center on the many options available to these communities, fully exploring the pros and cons of each and leaving attendees more confident about the decision making process. The session will open with the introduction to the new Municipal Government Sustainability Self-Assessment Tool, which can help towns and villages assess their strengths and weaknesses, and can assist them in making better decisions about how to make improvements. The second part will include a facilitated panel discussion between urban leaders who have embraced the need for change in their communities, looking at the decision making and implementation processes, and the resultant implications for their communities. The session will be facilitated by Jim Toye, City Manager for North Battleford, President of the Canadian Association of Municipal Administrators, and former President of the Urban Municipal Administrators' Association of Saskatchewan.

First Timers *Guide*

Helpful information for convention newbies

Never been to the SUMA convention before? Not sure what to bring? To wear? Where to go? No problem! Read on to get the bare essentials you will need before heading on the road to Regina!

What's included in my registration fee?

Your convention registration includes admission to all of the education and breakout sessions (your choice of sessions), a seat at the keynote speaker presentation, tradeshow viewing times Monday and Tuesday, shuttle service to and from host hotels, a light continental breakfast and lunch Monday and Tuesday, refreshment breaks, a chance to mingle with fellow delegates and SUMA board members during Monday's Hospitality Night (cash bar), the chance to dialogue with provincial cabinet ministers, and the opportunity to network with other municipal leaders. Sunday night's Stars of Saskatchewan event, the President's Banquet and the Partners' Program require additional fees.

What should I pack to wear?

Casual business attire is recommended for daytime activities. The Sunday night event is casual attire, and the President's Banquet is business formal. Please remember that you are representing your community, so put your best foot forward while at convention – you will be networking with urban governments from across the province, and will be in the presence of many provincial and national dignitaries. Please refrain from ball caps, sweat pants, ripped jeans, etc.

Remember that it's winter in Saskatchewan, and bring suitable outerwear for the trek to and from the hotel!

What should I do when I get to the Queensbury?

Be sure to drop by the Registration Desk to get your convention envelope (including your name tag, agenda card, voting information and pre-purchased event tickets). Your nametag is your admission ticket to the sessions and luncheons, and is a must-wear item during convention. At the event's close, these badges and holders will be collected by SUMA to reuse (and when you return yours, you are entered into a draw for an excellent prize!)

Each registered delegate will also receive a bag with the convention handbook. This handbook is an invaluable resource for every delegate, containing transportation information, facility floor plans, session details, resolutions, and day-to-day agendas.

Tell me about the meals!

A light continental breakfast will be served in the tradeshow area (Agriculture Building), and lunch will be served in Salon ABC (Queensbury Convention Centre) Monday and Tuesday. Refreshments are available in the tradeshow area Monday and Tuesday morning and in the foyer of Salon ABC Tuesday afternoon and Wednesday morning.

Appetizers and a cash bar will be provided at the Sunday night event, and a full course dinner will be served at the President's Banquet (tickets must be purchased in advance).

What about the AGM?

The AGM will be held Tuesday January 31, 2012 at 11:30 a.m. Any elected official whose municipality is a member of SUMA is able to vote during the AGM.

What are Sector Meetings?

Sector Meetings will be held on Monday January 30, 2012 at 3:30 p.m. and split into the following groups:

- Cities
- Towns
- Villages
- North

You are only able to vote in the particular sector to which your municipality belongs.

How does SUMA deal with resolutions?

Resolutions will be held on Tuesday, January 31, 2012 at 2:00 p.m.

The resolutions will be summarized in your convention handbook that will be provided on-site when you register at convention. Only those delegates with BLUE (voting delegates) name badges are able to vote on resolutions. As per SUMA Bylaws, the number of voting delegates a municipality has been assigned is based on population size. Each resolution will be moved by the Chair, and a member of the sponsoring council must second it (or it will fail). The seconder will be given three minutes to speak to the resolution. The chair will then ask for anyone who wishes to speak against the resolution. If there is no opposing view, then the question will be called. If someone wishes to speak against the resolution than normal debate occurs. Speakers are given two minutes. The seconder will then be allowed one minute to close debate. Voting will be by a show of blue voting cards, unless 25 voting delegates request a vote by ballot. Any call for a ballot vote must come prior to the call for votes in favour. In the case of a ballot vote, the ballots from delegates from the Cities of Regina and Saskatoon will be counted as seven votes. Procedural challenges will be resolved through consultation with our parliamentary advisor(s).

What happens at the Dialogue with Ministers and the Bear Pit?

Only those delegates that have BLUE (voting delegate), YELLOW (delegate) or ORANGE (municipal employee) are able to ask the ministers questions. You are only able to ask one question, and statements are prohibited. To allow as many questions as possible, you will be given 90 seconds to ask your question and you will be timed.

Municipal Marketplace Tradeshow

The Municipal Marketplace Tradeshow is held in conjunction with the annual convention. There will be over 155 exhibitors offering products and services that are relevant to municipality needs on a daily basis. Time is set aside for you to visit the exhibitors. Remember to enter your name into the prize draws – SUMA delegates are lucky people, and you don't know what prizes you could take home! The ballot entry forms are contained within the handbook.

Anything else?



Transportation Information

SUMA and the City of Regina are pleased to provide shuttle bus service for SUMA delegates to this year's convention.

Long-Term Sustainable Municipal Planning Part III: Planning for Action

By the Municipal Capacity Development Program

Strategic planning does not end with a mission statement. It takes hard work and focused action to affect change and get results. In the previous two articles, MCDP covered the initial components of strategic planning - vision, mission, values, assets and opportunities; but without action, your 'plan' is useless. If you have been following this series, you should have a clear idea of the importance of visioning, of naming challenges and opportunities, and identifying three or four top priorities. Each community priority is a symphony unto itself with parts, players, movements, and timing. This article will explain how to take local priorities and turn them into tangible outcomes using goals, objectives, activities, resources, leads and timelines.

Imagine a group of municipalities come together to discuss their individual issues. The group includes two RMs and three villages. The villages are all within 50 kilometres of each other and the RMs are adjacent. The name of their intermunicipal group is the "Fantastic Five Inter-Municipal Association." Village A has a well-used rink in disrepair and over capacity, Village B has a community centre in good condition that sees little use, and Village C has no recreation services at all. Families from RMs #1 and #2 also make use of Village A's rink and local sports programming, though under-capacity is an ongoing issue. Each individual community has a different priority; Village A, and RMs #1 and #2's priority is to improve

the rink to make it safe and maintain or increase capacity to meet local needs. Village B's priority is to find an effective use for their building. Village C's priority is to improve access to recreation to keep families in the community. Each municipality has different challenges; however, there are threads of commonality at a regional level. Identifying a **shared goal** among the municipalities will address why recreational services are a priority; a goal should always be positively worded. A common goal for this inter-municipal group might be *"To improve accessibility to safe, local recreational facilities and adequate community programming to enhance the quality of life in the region."*

An **objective** identifies the specific solution(s) needed to meet your goal. Noting regional assets and deficiencies, one pertinent objective for the Fantastic Five may be to *"Establish a Regional Recreation Board to oversee regional programming."* Using this objective, the group will then complete an action plan with **specific activities** or baby steps required to meet this objective; for example, developing an inter-municipal Community Resource Inventory of available programming, recreation and the wants/needs of the community members is a solid first step. Using **resources available**, such as existing infrastructure, individuals, organizations, and finances, the group will be able to begin the process of meeting their objective while keeping costs low. At the same time, listing all resources required that you may not have will help the group keep an eye out and work towards acquiring them; for example, new funding opportunities. In keeping on top of

action items, designate a **lead person** who will oversee the project and report back to the group. Projecting a reasonable **timeline** for completing each action item is essential to the planning process.

The above table comprises MCDP's Action Planning Worksheet used to assist groups through the planning process. Some groups will have more priorities, more goals and further objectives for their region. For each goal, a separate action plan worksheet can be created.

Following this strategy, in one year, the Fantastic Five Inter-Municipal Association will have established a Regional Recreation Board with a regional recreation plan, using existing infrastructure and programs, at minimal to no extra cost to their communities! A Regional Rec Board will allow the communities to share existing facilities, making community programming more effective. Subsequent benefits may also

include effective use of infrastructure, improved regional participation, inter-community events and programming, and a broadening base of local volunteers, athletes and artists to share skills and knowledge! Future objectives could lead to an expansion of facilities and programming; even a regional bus system to transport residents between communities for programs. This action plan system can work for any inter-municipal priorities, including formal planning and development, waste management, bylaw enforcement and countless other projects. The possibilities are indeed endless when municipalities organize together.
