## Returning Vital Event Records

As of December 2010, the role of Division Registration is discontinued. *The Vital Statistics Act, 2009*, states that all vital events records must be returned to the Registrar of the Vital Statistics Registry. Information Services Corporation (ISC) wants to help, and they need your cooperation.

At the beginning of August, ISC sent out packages explaining the benefits of returning records, instructions on how to package the records for shipping, and the shipping labels you will need to return the records you still have. The deadline for return is November 30, 2012.

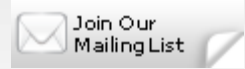
## Women in Municipal Politics

As the municipal politics scene in Saskatchewan gears up for elections, the Federation of Canadian Municipalities is trying to put a focus on more women on municipal councils.

FCM president Karen Leibovici issued a statement this week, saying: "FCM's efforts to bridge the gender gap in municipal governments are achieving real results, one election at a time...With support from Status of Women Canada, FCM has implemented a number of initiatives to recruit and train women to run in municipal elections. A series of campaign workshops and campaign webinars, supported by a campaign manual, have been held across Canada with encouraging results: almost 40 per cent of the workshop participants have been elected."

The United Nations designated Redberry Lake (including the nearby community of Hafford) as a World Biosphere Reserve on January 21, 2000.

A biosphere reserve is a natural environment where conservation takes place along with sustained economic use of resources. Natural aspects of the biosphere reserve include Redberry Lake and its islands, wetlands, grasslands, and aspen groves. The research and education centre at the lake carries out projects such as monitoring American White Pelicans and more than 180 other species at the Redberry Lake bird sanctuary.
