## Inter-municipal Connections at Convention

The SUMA Convention is just around the corner and municipal leaders will soon have a chance to network with each other and learn about a number of relevant municipal topics. Networking and education are two of the key ingredients for inter-municipal co-operation.

To build inter-municipal co-operation municipal leaders need to interact with each other; conventions provide a neutral, casual setting to meet other leaders in your area and talk about the current topics on the agenda. These networking opportunities over coffee, lunch, or after an educational breakout session provide the foundation to foster trusting relationships.

It is important to seize these opportunities, branch out and begin to build bridges with neighboring municipalities. Most relationships are built over time and begin with a conversation, whether on important municipal issues or simple topics like "KNOWLEDGE IS POWER. THE MORE INFORMATION MUNICIPALITIES GAIN FROM SPEAKERS AND EACH OTHER AT CONVENTIONS, THE GREATER THE POSSIBILITIES."

Saskatchewan winters. Without a healthy, open relationship, co-operation on joint projects and initiatives can be bogged down by mistrust and transparency issues.

Convention breakout sessions and keynote speakers provide information that can widen your knowledge of municipal topics. Most of these topics are concerns many municipalities face; these shared issues could be solved by a regional solution with surrounding municipalities. Knowledge is power. The more information municipalities gain from speakers and each other at conventions, the greater the possibilities.

So how can you gain the most from your convention experience?

- Attend sessions that are of interest to your municipal priorities. Participate in discussions and ask questions.
- Talk with municipal leaders who have found solutions to similar priorities. Learn the process they used, what challenges they faced and where they had success.
- Meet with municipalities from your region to discuss how you can implement joint solutions to common issues. Schedule a meeting to have further discussions within the next two months.

If your municipality is interested in working together with other municipalities but don't know where to start, the Municipal Capacity Development Program (MCDP) can help! MCDP can facilitate regional discussions, provide education workshops, and help you create an action plan.

## **Misconceptions About Convention**

There's no doubt that SUMA's annual convention is a critical event, giving our membership a chance to get together, debate resolutions, identify issues shared by our urban governments, and to foster unity among Saskatchewan's cities, towns and villages.

It might seem like Convention just happens, but Tania Meier is well aware of all the details that need to be taken care of in order for the annual event to run smoothly. As the Event and Corporate Services Manager at SUMA, Tania oversees everything Convention - though she's first to make it clear that she doesn't do it alone. It's a group effort for SUMA staff, and there is a Convention Planning Committee as part of the SUMA Board of Directors. The Committee approves the major parts of convention, like keynote speakers and education sessions. But Tania is the person behind making sure that the event looks seamless for delegates, meets the membership's strategic needs, is financially viable, and that no detail is missed.

#### What can we look forward to at Convention 2013?

Because this is the first year after a municipal election, there's lots going on, including the SUMA Executive elections. We'll have many people at Convention attending as first-time elected officials, so that is going to be exciting, too. Education is an important part of Convention, so on top of the regular education sessions, we will also have the Newly Elected Workshop, and on the Saturday before Convention begins, the Municipal Leadership Development Program will be offering other modules.

#### You survey delegates to see what they thought of Convention each year; what do you do with all the feedback?

After it's compiled, it's summarized and reported back to our Board of Directors. From there, the Convention Planning Committee takes the feedback into consideration, making changes where possible for the following year. For example, delegate feedback led us to create the First-Timers' Guide, to help those new to Convention learn the ins and outs.

Certainly, we can't make every change that is asked for, but we make every effort to deliver a good, quality program, and delegate feedback is extremely important.

#### It seems that a lot of the feedback is tied to food! What's your take on this?

There are significant costs associated with food and other materials we require for convention. It's definitely not cheap to host an event at a facility like TCU – or anywhere else, for that matter. To put things in perspective, our breakfast costs are \$11.50 per person per day, and lunch costs are approximately \$18.00 per person per day. Our coffee and tea expenses for the breaks are nearly \$11,000.

We do receive a lot of feedback about food. And, while there are likely those that would be willing to pay more for meals, we must make every effort to keep Convention accessible and affordable for everyone. The goal is to keep registration affordable to provide an opportunity for all of our members to attend.

## Aside from the food costs, are there some other expenses that you think would surprise people?

Well, I think it's important to note that even the things we really don't think

about cost money. For example, the screens that appear in the main convention hall are \$800 per screen per day to rent, so our total costs on that are almost \$13,000.

Bussing is another significant cost at \$25,000, a cost that is offset with a grant from the host city. We could increase service and have buses running all day and going to more hotels, but it would be quite easy to double the cost of this service. These are just a couple of examples, but the bottom line is that everything costs money – and costs continue to rise every year.

"WE MAKE EVERY EFFORT TO DELIVER A GOOD, Quality program, and delegate feedback is extremely important." We've also been asked why we don't consider other locations like Prince Albert or Moose Jaw. How do you respond to this?

Firstly, there are really only a few facilities in the province that can accommodate our needs. There are TCU Place and Prairieland Park in Saskatoon. In Regina, our options are the Queensbury Centre and the Conexus Arts Centre. We need a meeting room for about 1,200 people, a large tradeshow space and various other meeting rooms.

As for other cities hosting, in addition to the convention facility issue, there would simply not be enough hotel rooms for us. Most hotels in Regina and Saskatoon are full around the time of our convention, and while it would be nice to offer another city the opportunity to host, we would not put ourselves into a situation where we couldn't accommodate all delegates. And, I don't know anyone that wants to camp in Saskatchewan in February! (Laughs)

#### How important are sponsorship and the Municipal Marketplace tradeshow to the success of the event?

The tradeshow always gets great reviews, and I think that people understand the revenue that the tradeshow generates, and also the valuable connections that it provides for our members and partners. In addition to the delegates liking the tradeshow, our exhibitors are really happy, too.

Wherever possible, we look to offset costs through sponsorship. For example, our education session speakers are usually there for free and come on their own time. We pay for the keynote and entertainer, and again, offer these up as sponsorship opportunities to offset costs. We also provide other options, such as the opportunity to address delegates and handbook advertising.

#### Putting this convention together is an incredible amount of work. Which part is most rewarding?

I think the fact that most everything is planned in house, by staff. We generate a lot of work out of our small office, and I may be biased, but I think that we

We do contract one person to manage tradeshow, sponsorship and advertising because we don't have the capacity to handle that, and we pay a relatively small fee to contract the Partners' Program, but otherwise, it's 13 of us. Everyone works hard, and I'm really proud of our team.

## First-timers' Guide to Convention

I f this is your first time attending a SUMA convention (or even if you are a returning delegate), read on for tips on anything from registration to shuttle services.

#### What does my registration fee include?

- Your convention registration includes:
   admission to all of the education and breakout sessions (though you choose which to attend);
  - both keynote presentations;
  - admission to the tradeshow, with time set aside to visit on Monday and Tuesday;
  - scheduled shuttle service to and from host hotels;
  - a light continental breakfast and lunch Monday and Tuesday;
  - · refreshment breaks;
  - a chance to mingle with fellow delegates;
  - the chance to dialogue with provincial cabinet ministers; and
  - the opportunity to network with other municipal leaders.

Events that require additional fees are Sunday night's Fire & Ice event, the President's Banquet and the Partners' Program.

#### Where do I register at TCU Place?

When you get to TCU Place, swing by the Registration Desk; it will be at the entrance of the main doors.

The Registration Desk is where you get your convention envelope (including your name tag, agenda card, voting information, pre-purchased event tickets, and Partners' Program packages). Your nametag is your admission ticket to the sessions and luncheons, so it is a must-wear item during convention. At the end of convention, these badges and holders will be collected by SUMA to reuse and your name will be entered into a draw for a prize.

Each registered delegate will also receive a bag with the convention handbook. This handbook is an invaluable resource for every delegate, containing transportation information, facility floor plans, session details, resolutions, and day-to-day agendas.

The registration desk will be open:

- Sunday, February 3: 11:00 a.m-4:30 p.m.
- Monday, February 4: 8:00 a.m.-5:00 p.m.
- Tuesday, February 5: 8:00 a.m.-5:00 p.m.
- Wednesday, February 6: 8:00 a.m.-12:30 p.m.

#### What should I wear?

Casual business attire is recommended for daytime activities. The Sunday night event is casual attire, and the President's Banquet is business formal.

Please remember that you are representing your community, so put your best foot forward while at convention – you will be networking with urban governments from across the province, and will be in the presence of many provincial and national dignitaries. Please refrain from ball caps, sweat pants, ripped jeans, and other unprofessional attire.

#### What about the food?

A light continental breakfast will be available in the tradeshow area on Monday and Tuesday. A lunch buffet will be served in the Grand Salon on Monday and Tuesday. Refreshments are available in the tradeshow area Monday and Tuesday morning and in the foyer of the Grand Salon Tuesday afternoon and Wednesday morning.

Appetizers and a cash bar will be provided at the Sunday night event, and a buffet dinner will be served at the President's Banquet. Tickets must be purchased in advance for these two events.

#### When are the SUMA Executive elections taking place?

The Presidential election will take place on Monday, February 4 at 11:45 a.m. Each candidate will be given time to speak and immediately following you will be able to cast your vote. Each elected official will be eligible to cast one ballot upon presentation of his/her convention delegate badge.

The Vice-President of Towns and the Vice-President for Villages, Resort Villages and Northern elections will take place during the sector meetings on Tuesday,

February 5 at 9:00 a.m. Each elected official will be eligible to cast one ballot for their respective sector Vice-President upon presentation of their convention delegate badge.

If required, the Saskatoon/Regina Executive member will be elected by the delegates from Saskatoon and Regina at the City Sector meeting on Tuesday, February 5 at 9:00 a.m.

#### When is the AGM?

The AGM will be held Monday, February 4 at 3:00 p.m. Any elected official whose municipality is a member of SUMA can vote during the AGM.

#### What are Sector Meetings?

Sector meetings give delegates a chance to meet with colleagues from other urban governments in the same sector. The meeting is a chance to discuss current issues and for discussion items from the floor. They will be held on Tuesday, February 5 at 9:00 a.m. and split into the following groups:

- Cities
- Towns
- Villages, Resort Villages, and Northern Municipalities

You are only able to vote in the sector to which your urban government belongs.

#### What is the deal with resolutions?

The resolutions session will be held on Tuesday, February 5, at 1:00 p.m.

The resolutions will be summarized in your convention handbook, provided onsite when you register. Only delegates with BLUE (voting delegates) name badges are able to vote on resolutions.

As per SUMA Bylaws, the number of voting delegates assigned to a municipality is based on population size. Each resolution will be moved by the Chair, and a member of the sponsoring council must second it (or it will fail). The seconder will be given three minutes to speak to the resolution. The Chair will then ask for anyone who wishes to speak against the resolution. If there is no opposing view, then the question will be called. If someone wishes to speak against the resolution then normal debate occurs. Speakers are given two minutes. The seconder will then be allowed one minute to close debate.



Voting will be by a show of blue voting cards, unless 25 voting delegates request a vote by ballot. Any call for a ballot vote must come before the call for votes in favour. In the case of a ballot vote, the ballots from delegates from the cities of Regina and Saskatoon will be counted as seven votes. Procedural challenges will be resolved through consultation with our parliamentary advisor(s).

#### What are breakout sessions?

Breakout sessions are sessions that are split between the below groups and focused on a topic of particular interest to each group.

- Cities
- Towns and Villages with populations below 500
- Towns and Villages with populations
   above 500
- Northern (This session acts as the Northern Regional Meeting, and in 2013 delegates will elect the Northern Regional Director to serve on the SUMA Board of Directors.)

Breakout sessions will be held on Tuesday, February 5 at 2:45 p.m.

What happens at the Dialogue with Ministers and the Bear Pit? Only those delegates that have BLUE (voting delegate), YELLOW (delegate) or ORANGE (municipal employee) badges are able to ask the ministers questions. You are only able to ask one question, and statements are prohibited. To allow as many questions as possible, you will be given 90 seconds to ask your question and you will be timed.

#### **Municipal Marketplace Tradeshow**

The Municipal Marketplace Tradeshow is held in conjunction with the annual convention. There will be more than 155 exhibitors offering products and services that are relevant to municipal needs on a daily basis. Time is set aside for you to visit the exhibitors. Remember to enter your name into the prize draws – SUMA delegates are lucky people, and you don't know what prizes you could take home! The ballot entry forms are contained within the handbook.

#### Anything else?

Watch for SUMA staff members – we'll be the ones with red nametags. Please do not hesitate to come over to say 'hello' or let us know if we can be of assistance. We love to hear from our members!

A Newcomers' Orientation session will be held on Sunday, February 3 at 4:20 p.m. You will get an overview of how convention works, the agenda, and how you can get the most out of it.



## **Policy Opportunities at Convention**

S UMA was founded in 1906. Our Association exists to promote, protect, and defend the interests of our members. The primary way we represent these interests is by advocating on behalf of the 448 cities, towns, villages, resort villages, and northern municipalities that are members of SUMA.

For more than a century, SUMA has worked to better understand the interests of our members. We are always looking for new ways to engage with you, learn from you, and deliver victories for you. But we can't ignore the tried and tested ways, like our annual convention.

Each year SUMA members come together at convention to discuss the important issues of the day. Convention offers delegates multiple opportunities to have direct input into SUMA's policy development and advocacy work. To prepare you for Convention 2013, let's explore these opportunities. We want you to know how you can most directly influence the work we are doing on your behalf.

#### **Resolutions**

The Tuesday afternoon resolutions session gives delegates the chance to influence SUMA's policy directions by adopting resolutions for the Board of Directors' consideration. These resolutions help guide the Association's strategic priorities for the next year.

#### **Sector Meetings**

This year, the sector meetings on Tuesday morning will include elections. However these meetings will also provide delegates with sector-relevant updates on key policy files. Delegates will have the opportunity to ask questions and provide suggestions for new policy priorities.

#### **Annual General Meeting**

At SUMA's formal AGM on Monday afternoon, delegates will receive a report on our activities in the past year. This session also gives delegates the chance to ask questions about SUMA's advocacy priorities and our progress in advancing the interests of our members.

#### **Ministerial Dialogue Sessions**

Wednesday morning's dialogue sessions with provincial cabinet ministers are a key opportunity to ensure your voice is heard. SUMA





has invited eight members of cabinet to participate in this year's dialogue sessions. These sessions allow delegates to ask specific questions to ministers in a more focused way than the Bear Pit allows.

#### The Bear Pit

The Wednesday morning Bear Pit session is the final event of the SUMA convention and is often the highlight. With the Premier, Cabinet, and members of the media attending, delegates have the chance to ask questions about their priorities and get answers directly from the provincial decision-makers.

#### **Meetings with Ministers**

On top of scheduled events, many cabinet ministers are willing to meet with individual SUMA member governments during the convention. If you are interested in meeting with a particular minister during Convention, contact the minister's office directly, or call SUMA and we will point you in the right direction.

#### Electing Board Members

SUMA members will finalize the election of the Association's Board of Directors, as this is the first convention since the municipal elections. On Monday, delegates will elect the President, and on Tuesday several Vice-Presidents and the Northern Director will be elected. These board members, along with those elected through their regions, are responsible for representing your interests over the next four years. Finding out more about the candidates is one way to ensure that your voice will be heard and your interests represented.

#### Meeting with Board Members & Staff

Finally, SUMA members are encouraged to get to know your board members and the staff members of SUMA during Convention. We are here to represent you, and we want to get to know you. While we may not have time for a formal meeting at Convention, we would love to chat informally, exchange contact information, and plan to connect following the event.

There are many opportunities to influence the policy and advocacy work of SUMA at our annual convention. This is an opportunity for you, and a necessity for us. Active engagement of our members is the only way we can be the voice of urban Saskatchewan.

## **Education Sessions**

#### Sunday, February 3

#### Public Advocacy: How to effectively influence your local MLA

This session will show you how to advance local issues with your MLA and other provincial officials. Learn the secrets of effective advocacy and get some valuable tips and tools for future success. The session will also cover how you can get involved with provincial advocacy efforts coordinated by SUMA.

#### Labour Law: What you should know

Council is responsible for the overall governance of a municipal government. This includes making sure the municipal administration follows provincial labour legislation.

This session focuses on the current labour laws that a council needs to know. What are the minimum labour standards your municipality must follow? The session will also cover legal trends in today's labour laws, with information on what council must include in its human resources policy.


#### The Ask an Expert Panel

Do you have a question about community planning, municipal administration, or environmental regulations? Maybe you can get the answer at Convention 2013! At this session, a panel of municipal experts will be there to answer your questions. Learn from masters in solid waste management, water/wastewater systems, community planning and municipal administration.

If you already have a question in mind, you can submit it in advance – however delegates are welcome to ask the speakers directly at the session. Submitting your question now to *cchung@suma.org* will allow our experts to research and prepare an answer to your question.

#### Emergency Planning for your Community

Every moment is critical in an emergency, and municipalities need to be able to share and find information as quickly



During this session, attendees will learn about MASAS, how their municipality can benefit from its use, and the long-term prospects for management and funding. Attendees will also learn about the importance of developing and updating an emergency plan for their community.

#### Safeguarding your Financial Assets

Employee theft from a municipality can be devastating to the community, more than perhaps any other sector. Saskatchewan municipalities are not immune. This session will shed light on just how big the problem is and give both staff and elected officials invaluable practical knowledge on detecting, controlling and preventing these types of criminal losses.

#### The Untold Story of Recycling

Many urban governments provide recycling programs, but do you know the story past the recycling bins? Can you tell citizens what happens to the materials they recycle?

Hear the untold story of recycling from storytellers who work in the recycling business. Speakers will cover the steps your recycling takes: from collection to separation, selling the salvageable material to what your recycling turns into after it leaves your recycling bin.

#### **City Dialogue Session**

This session is for delegates from cities only. This is a chance for the Saskatchewan City Mayors' Caucus (CMC) to review its work from the previous year. At this session you will hear a report from the CMC, and have a chance to identify high-priority items for the coming year's work.

#### **Newcomers' Orientation**

If this is your first time at convention, check out this session. There will be an overview of how convention works, the agenda, and how you can get the most out of it as a delegate.

#### **Tuesday, February 5**

#### Cities

Public and stakeholder engagement can lead to situations of high emotion, conflict or controversy. You may wonder what role the public can play when making complicated and challenging decisions. When, where and how to begin consultations? What happens if things get emotional? Do you have the tools to diffuse potentially explosive situations?

This session will cover how to engage the public in meaningful conversations for better results. The session will help local councils take away proven practices to make and carry out decisions with effective engagement.

#### Towns and Villages with Population over 500

Keynote speaker, George Cuff, will also be at this session, sharing his expertise on transforming council administration working relationship.

The session will start with an overview of operational vs. governance council model and traits of an operational council. George will explain the advantages of a governance council, and suggest ways for council to build a better working relationship through this model. He will offer steps for council to work toward a successful governance model.

#### Towns and Villages with Populations below 500

As an elected member of council it is your responsibility to serve your community's interests. Your decisions impact current and future residents.

Council must plan for the future to ensure a safe, healthy, and vibrant community. Planning is an important part of governing your community; it helps establish priorities and a direction for the work of council. This session provides insight into the fundamentals of planning, and offers attendees information on the tools and resources available to help you plan.

#### Northern Regional Meeting

During the regional meeting delegates from northern municipalities will elect the individual who will represent them on the SUMA Board of Directors for the next four years. Only elected mayors and councillors from SUMA member northern municipalities are eligible to vote and seek election.

After the election, this session will involve dialogue with provincial officials about an issue of primary importance to northern municipalities. This issue will be determined through SUMA consultation with New North and its members.



## **Executive Elections**

onvention 2013 will see plenty of new faces, and that includes
 elections for three SUMA Executive Committee positions:

- President
- Vice-President of Towns
- Vice-President of Villages/Resort Villages/Northern
  Municipalities

You can submit your nomination immediately. Nominations for the President must be returned to the SUMA office by 11:45 a.m. on Sunday, January 20, 2013. Sector Vice-President nominations can be submitted before Convention, or onsite until 9:00 a.m. on Monday, February 4, 2013. Nominees for all positions must be elected officials of a SUMA member council in good standing.

Any elected official from a SUMA member municipality in good standing is eligible to run in the Presidential election. The election will happen on Monday.

To run for Vice-President of Towns, you must be an elected official from a town council that is a SUMA member in good standing. Nominees for the Vice-President of Villages, Resort Villages and Northern Municipalities must be an elected official from a village, northern town, northern village, northern hamlet or resort village council that is a member of SUMA in good standing. Any unsuccessful candidate for the position of President can notify the returning officer by 9:00 a.m. on Monday, February 4, 2013, if they wish to run for Vice-President of the appropriate sector without having to file new nomination papers. The elections for the Vice-President positions will happen at the sector meetings Tuesday morning.

The Vice-President of Cities is the Chair of the City Mayors' Caucus, and depending on election results, a Regina/Saskatoon Executive Member may be selected at the City Sector Meeting on Tuesday morning. Those individuals will make up the SUMA Executive Committee for the next four years.





ell, it is easy to say that 2012 has been a busy year for municipal offices across the province. Councils and administrative staff have dealt with community development, zoning policy issues, asset management, and preparing for 2013 reassessment, just to name a few things.

All of these issues, and others, require a great deal of time and effort to understand, to analyze, and to prepare information for elected officials to make informed decisions. It is extremely important that councils are presented with good, wellreviewed and well-presented information to make decisions on behalf of the electorate. It is just as important in ensuring that the administrative staff at the municipality is well trained and given the opportunity for further education and development.

The current economic engine in the province of Saskatchewan has provided for a time of growth and expansion in our municipalities that has not been seen in more than half a century. The impacts of community growth have enhanced the stresses on municipal staff to ensure community development meets established planning and zoning requirements that are in place. There are a number of avenues available for municipalities to keep administrative officials informed and better educated on these matters.

The Ministry of Government Relations, UMAAS, SUMA and other fraternal organizations hold a variety of education workshops and sessions across the province each year. These workshops play a vital role in providing up-to-date information on key municipal issues and in turn, are so very important for administrative staff in increasing and diversifying their knowledge base.

Further to this are the annual SUMA and UMAAS conventions. These annual conventions, through sessional workshops and plenary sessions provide for further education of administration officials. Not only do the education sessions allow administrative staff to enhance their knowledge base, they also provide a formal and informal avenue for information sharing between colleagues.

As the issues around all municipalities become more complex, the work necessary to accommodate responses to the issues becomes greater and more compound. I would encourage all municipal councils to prioritize and support training and ongoing education of administrative officials as we all work together to provide our taxpayers with efficient service delivery and good governance.

## SAMA AND THE 2013 REVALUATION

The Saskatchewan Assessment Management Agency (SAMA) is responsible for a \$94 billion property assessment base. This is used by local governments to levy a \$1.4 billion property tax base.

SAMA oversees a full revaluation of all properties in the province every four years to implement a new base date. The base date is the valuation date to which all assessments are related.

The current assessments in Saskatchewan use June 30, 2006 for a base date. January 1, 2011 will be the base date for the upcoming 2013 Revaluation. We want 2013 Revaluation to accurately capture the substantial growth in real estate values between 2006 and 2011 for our client municipalities.

#### **ASSESSED VALUES FOR 2013**

The province of Saskatchewan has experienced unprecedented economic growth, and the value of property in the province is no exception. The result of this active and strong real estate market in Saskatchewan will bring with it significant increases to property assessments that will be reported with the 2013 Revaluation.

Based on provincial averages, initial numbers show residential and resort residential properties will – on average – approximately double over their assessed values from the 2009 Revaluation. Specific local increases in residential assessed values may vary from this, depending on the overall trend in local market values between June 30, 2006 (the base date for the 2009 revaluation) and January 1, 2011 (the base date for the 2013 revaluation).

Agricultural land will see an increase of approximately 50 per cent to assessed values, which reflects the change in the provincial average selling price of agricultural land. Heavy industrial property, such as mines, and oil and gas wells will see an increase of between 10 and 15 per cent, while overall commercial property assessment trends indicate average increases of 55 per cent – though there will be significant variations from that average depending on local market strength.



#### LOOKING FORWARD TO 2013

SAMA submitted preliminary assessment values to the province in April 2012, and began distributing preliminary values to municipalities in June. SAMA encourages municipalities to contact us should you have any questions or concerns about your preliminary assessment notices.

The Agency will complete final assessments and be prepared to send out updated values by the end of 2012. SAMA will work closely with our client municipalities to meet their needs regarding these new assessed values. In an effort to improve the transparency of assessments to the public, the Agency is revamping our SAMAView web application to allow the general public access to individual property assessment details for all SAMA client jurisdictions for January 31, 2013.

## SUMAssure – BRINGING MEMBERS PEACE OF MIND

The SUMAssure Insurance Reciprocal is growing by leaps and bounds. Since 2008, SUMAssure has offered Saskatchewan's urban governments a chance to get off of the traditional insurance treadmill and control their own insurance costs by owning their own insurance company. This clearly was an opportunity worth undertaking, as subscribing members have seen their insurance coverage improve, their insurance rates go down, and subscribers have gained considerable equity in the reciprocal and all within just a few short years.

On October 1, 2009, SUMAssure began operations as the first-ever Saskatchewan-domiciled insurance reciprocal. For years, reciprocals based elsewhere in Canada have operated in Saskatchewan protecting organizations like our universities and hospitals. Since the late 1980s insurance reciprocals for local governments have been well established in other provinces. Those groups have years under their belts and war chests full of money. Saskatchewan appears to be catching up!

Great...but what exactly is an insurance reciprocal?

Let **Jason Minvielle** explain. Jason is one of the many Regina- and Saskatoonbased employees of Aon Risk Services that work on the SUMAssure Insurance Reciprocal.

"The entity is called a reciprocal because each urban municipality shares reciprocal agreements of indemnity with the other urban municipalities," Jason says. "Basically, they agree to mutually share in each others' losses up to a certain point. All risk over the limit that the group assumes in the reciprocal is transferred to excess insurers.

"Originally SUMAssure was structured for the subscribers to absorb the first

\$250,000 in liability claims and the first \$250,000 in property claims, the maximum possible exposure for the group being \$500,000 that first year. The program has already evolved to where the group can now absorb a combined total of property and liability losses of \$750,000.

"That amount essentially acts as a large group deductible to save premium dollars by providing a buffer between our municipalities and the insurance marketplace. Anything over and above the annual aggregate is transferred to excess insurers. Before we even start a new policy period on October 1 of any given year, we can pretty much determine our year-end profit within just a few dollars."

Today, the total combined insurable value of SUMAssure's subscribers is well over a billion dollars. When SUMAssure comes knocking, looking to place excess insurance coverage for the group, even Bay Street takes notice. By placing excess insurance coverage together as a group, the smallest resort village in Saskatchewan can have marketing power that was impossible alone in the traditional insurance marketplace.

Aon manages both the day-to-day operations of SUMAssure, and the financial and regulatory requirements required by various statutes. SUMAssure is regulated by *The Saskatchewan Insurance Act* via the Superintendent of Insurance, and governed by a Board of Directors – the majority of which is made up of administrative and elected officials from SUMAssure's subscribing municipalities.

Aon's job is no small task, as it not only manages the Guarantee and Reserve Funds required by the Act, but also has to manage the group's ever-growing surplus funds. "It is nice when I can go to a council meeting and I can actually quantify the equity any town or village has in SUMAssure after only a few years," says Jason. "I was attending an evening council meeting a few weeks ago and another broker was pitching an alternative insurance quote to the town. Although the premium was about \$40 lower annually, it was from a traditional insurance program based in Ontario."

Jason was able to illustrate to council that the municipality had already earned over \$18,000 in equity in the SUMAssure program. He estimated that the equity would increase by another \$12,000 by October 31, 2012. "It kind of made the decision a no-brainer for council when they realized they would be walking away from \$30,000 to save \$40."

What to do with those ever increasing surplus funds is a decision that the SUMAssure board will address over time. Aon is advocating a "stay the course" direction for SUMAssure but there is increasing pressure from subscribing municipalities to begin issuing dividends already.

Jason shares Aon's position that dividends should not be issued until the group's surplus funds exceed \$5 million or perhaps even \$10 million.

"The point of SUMAssure's establishment was to stabilize insurance rates and provide a level of budget predictability and not become a revenue stream for subscribers. However, all that being said, we do take our direction from the subscribers through their Board of Directors so if that is the decision, we will abide by it.

"The money belongs to the subscribers, not Aon, not SUMA and certainly not the insurance companies. It is a good problem to have and I am pleased to see the financials so strong for the group. We continue to grow on all fronts – better coverage, membership and surplus funds. More municipalities are embracing the reciprocal concept so those surplus funds are really going to have a snowball effect and grow at an even faster pace. The dividends will come but we want our group to be prepared for the next inevitable spike in insurance rates. That day *will* come and SUMAssure will be ready. Our members can rest assured that they are building a house of stone and not straw," says Jason.

As Jason continues, he explains how rewarding it is for him to meet with a council that fully understands the significance of what SUMAssure is working toward. Even more rewarding for him is when the local insurance broker from a town or village is actually a member of council and fully supports the program. "When you have the local broker stand up and say 'Hey, I simply cannot offer the same level of coverage for the same price and, at the same time, have my municipality earn equity in SUMAssure to secure a better future for my municipality'. It is their community too after all and you can't help but respect a business person that can appreciate the bigger picture like that."

SUMAssure's membership base continues to grow. Originally set up with 132 municipalities including one city, SUMAssure has grown to include 56 towns, 79 villages, 15 resort/northern villages, two utilities and four cities.


Interest from the other larger centres is growing rapidly. The cities of Meadow Lake and Humboldt are some of Saskatchewan's larger centres to recently subscribe to the SUMAssure Program. **Steve Brown**, Director of Finance for the City of Humboldt, was so impressed with SUMAssure that he has become its newest board member.

"Risk management and loss prevention are key areas that SUMAssure will be concentrating on in the near future while investigating innovative ways to add value for subscribers," Steve says. "Rather than just paying premiums and waiting for a claim to possibly happen, SUMAssure is proactive and attempts to prevent losses before they happen. Recently, SUMAssure has provided seminars and risk management bulletins on managing special events, environmental impairment liability for the public sector, insuring to value and has an upcoming seminar on preventing crime losses. The additional training and communication provided by SUMAssure was additional value received by the City of Humboldt in addition to the competitive pricing and improved insurance coverage."

Brown and the rest of the SUMAssure Board of Directors are excited about the future of SUMAssure as the group now has more funds to embark on further risk management initiatives beginning in 2013 with full risk control and loss prevention assessments on SUMAssure's top 120 exposures to loss.

"Essentially, every facility that the group insures over \$2 million in value will be professionally inspected and, next year, we hope to inspect another 50 sites. SUMAssure is putting its money where its mouth is and is investing in our subscribers. Every member, not just the municipalities that own them, benefits from preventing loss at those locations. It's more money in everyone's pocket at the end of the day," Steve says. "That's the benefit of subscribing to SUMAssure."
