Update on our Federal Election Advocacy

We are now just over nine weeks into the 2015 federal election campaign. Election Day - **Monday, October 19** - is just a few weeks away.

SUMA launched our federal election advocacy campaign early this month, after the Labour Day weekend. So far, we've focused on public safety (disaster relief, rail safety, and climate change) and municipal infrastructure. In the next three weeks we will tackle quality of life and the mandatory long-form census.

Since we launched the campaign, it has garnered some positive recognition in both the press and by our federal counterparts at the Federation of Canadian Municipalities. We received the following coverage through local and national media outlets:

We encourage all members to continue to share and re-tweet our content and further Amplify Our Voice by spreading the message that municipal issues must be an important part of any national agenda following this federal election.

We look forward to using these last three weeks of the campaign to bring attention to quality of life issues, and the need to reinstate the mandatory long-form census. We appreciate your support, and encourage you to help us keep our voice amplified as we wrap up this advocacy campaign.



Notes From the Board Meeting

The SUMA Board of Directors also gathered last Friday for our quarterly Board meeting. Here are a few items of note from our day.

Convention Planning Committee

- Convention 2016 rates were confirmed: \$300 for early bird member registration, \$400 after the early bird deadline, \$35 for the Sunday's welcome reception, and \$60 for the President's Banquet.
- The Welcome Reception will take place at Mosaic Stadium at Taylor Field and include the chance to tour the Green and White Lounge, Alumni Room, and Saskatchewan Roughrider dressing room. The committee decided on Amy Nelson and the Rider Pep Band as the entertainment for this event.
- The entertainment has been confirmed for the President's Banquet. Jeffery Straker will perform during dinner finishing off the evening with a great show from The Dead South.
- The education and breakout session topics were finalized along with the agenda. Watch for more details in the coming weeks when we open registration.

Board Meeting

• We heard about the revisions to the Multi-Material Recycling Program (MMRP), introduced by Multi-Material Stewardship Western (MMSW) to respond to province's December 2014 announcement which introduced exemptions and a two-year transition period. The province will review the revised program in October, and if approved, the revised MMRP will launch on January 1, 2016.

- The Board adopted three new policy statements:
 - Municipal Climate Adaptation
 - Urban Highway Connector Program
 - Fine Revenue Distribution
- There were updates on provincial proposals to amend municipal conflict of interest legislation and essential services legislation, which will be introduced in the upcoming fall legislative session starting October 13. If you're attending the regional meetings over the next couple of weeks, also expect discussion on the changes to municipal conflict of interest legislation there.
- Work by the province, SUMA and SARM on new boundary alterations guidelines has been successful and these guidelines will soon be announced. These guidelines will provide assistance to urban and rural municipalities in reaching agreements to alter municipal boundaries, setting out responsibilities for each in working to reach consensus on contentious issues.
- We discussed the new federal grade crossing regulations and how SUMA can help our members with their information gathering before the November 2016 deadline.
