# Hot start to a cold new year

Premier Wall, Minister Hutchinson signal that a new revenue sharing program is near

The provincial government has started 2009 on the right foot - at least, that's what representatives Saskatchewan's from municipalities are thinking. Premier Brad Wall and Municipal Affairs Minister Bill Hutchinson have been in the media talking about a new, more predictable revenue sharing program that delivers more dollars to Saskatchewan's municipalities.

In a CBC interview that aired on January 5, Premier Wall indicated that his government is looking at sharing PST revenues with the province's municipalities. Under this formula, the province would do away with the complex ad hoc calculations of recent years and offer municipalities a more predictable, simpler share in sales tax revenue, he said.

Minister Hutchinson also talked publicly about a new revenue sharing formula that would share sales tax revenue, and went on to emphasize the urgency of financial support to municipalities.

"Municipalities have made the point repeatedly and clearly - and I think very correctly - that the property tax base alone simply does not provide municipalities

with enough dollars to meet all of their ongoing requirements year-by-year. They provide a very wide range of services to their residents with a very narrow range of revenue sources," said Hutchinson in a recent Leader-Post interview.

SUMA President Allan Earle welcomed the province's New Year overtures, saying that revenue sharing remains the top priority for urban municipalities.

"When it comes to revenue sharing, municipalities have been banging at the door for at least 15 years. The number one priority for Saskatchewan's cities, towns and villages has long been a new revenue sharing program that delivers adequate funds in a predictable, transparent way," Earle said.

SUMA has worked closely with the province and other stakeholders to develop the revenue sharing proposal now being considered by the Provincial Cabinet. One of the proposal's recommendations is that revenue sharing should be linked to the PST, the option that is now being aired publicly by the Premier.

"SUMA has been working diligently with Municipal Affairs to put together a solid proposal for revenue sharing. So, to be at this stage after just 12 months - with the Provincial Cabinet considering our proposal, with the Premier and Minister Hutchinson talking about it publicly - it just goes to show how strong the government to government relationship in this province is," Earle said.

President Earle remains hopeful that municipalities will finally see a new revenue sharing program, adding the proposal that SUMA helped to develop is backed by all Saskatchewan municipalities both urban and rural.

"SUMA and SARM are presenting a united front. We've gone together to the government and said 'Look, we fully support this. The whole province - urban and rural - is behind this revenue sharing proposal'. As a provincial government, that's as clear a signal as you'll ever hear," Earle said.

Progress on revenue sharing will be provided through SUMA's weekly Urban Update email.

Here we are: the start of another fiscal year for municipalities. Already a number of important events stand out on the municipal agenda for the coming year.

CEO's

Of course, 2009 is a municipal election year for cities, towns and villages. As always, elected officials will be looking for all available options to balance municipal budgets and to ensure that local residents get the best delivery of services possible. The preparation of annual operating and capital budgets is always an excellent opportunity to consider the extensive array of products available through the SUMA Advantage program. In my last message, I shared the proposed work plan of the different groups working on the MSSP. There are many items on the agenda, and SUMA will engage on numerous files to address key issues affecting the municipal sector. Hoping that revenue sharing may soon be resolved, we are looking forward to reporting further progress on the Saskatchewan made infrastructure program, the multi-material recycling program, affordable housing and other files we are exploring with the Province.

By the time this issue goes to press, we will also have heard more from the Federal Government's proposed initiatives with respect to municipal infrastructure. SUMA President Allan Earle and I met with Minister Baird in Vancouver shortly before Christmas to reiterate the position issued by the Federation of Canadian Municipalities. An injection of funds by the Federal Government to assist municipal governments with infrastructure projects is one of the most efficient ways to stimulate the economy.

Infrastructure funding as an economic stimulus is fair to Canadians, because it benefits everyone. It is efficient, because there is currently a backlog of "ready to go" projects which have been identified by cities, towns and villages throughout the country. Almost instantly, it creates new jobs, stimulates the local economy and further contributes back to the provincial and federal revenue streams through income tax and goods and services taxes. FCM has already estimated that these taxes combined would return 35 per cent of any federal spending on municipal infrastructure back to the provincial and federal governments.

In closing, the entire SUMA administration is looking forward to meeting with our elected officials in Saskatoon on February 2nd. As always, we hope that the content of our education sessions, plenary presentations and trade show will bring new thoughts and solutions to meet the everyday challenges of our municipal governments. Mostly, we know that the Convention is the perfect opportunity to meet colleagues and friends who share a common vision of civic government.

# Tumbling prices have recycling programs in jeopardy

Province must provide bridge funding to sustain municipal recycling programs

It's a sad economic reality: much like the value of your investment portfolio, prices for recyclable materials have fallen dramatically in the wake of the worldwide economic slow down. The value of materials such as cardboard, plastic, tin and paper have had their value fall to what are being described as 'unprecedented levels', leaving those operating recycling organizations and private companies in our province scrambling to find solutions.

A recent CBC News story by Niall McKenna reported that the Parkland Regional Waste Management Authority in East-Central Saskatchewan once made a profit of \$110 for every tonne of cardboard it collected. By November, prices had plummeted to \$50, and then down again, to the point where the cost of transportation exceeded any profit that would have been made.

While the short-term response to this challenge for many organizations like the Authority has been to stockpile materials with the intent to wait for an upward swing in prices, other organizations do not have the luxury of adopting this 'wait and see' approach. The current situation has some groups facing the risk of being shut down immediately, which would leave many communities with no alternative but to put recyclable materials into landfills. Another concern is the risk of losing the public's engagement and commitment to recycling, a problem that has groups like SUMA and the Saskatchewan Waste Reduction Council (SWRC) encouraging the provincial government to take action.

In December, the SWRC sent a letter to the Premier, urging the province to provide immediate short-term funding for community recycling programs. While the province has not provided any money, Yorkton MLA Greg Ottenbreit has been appointed legislative secretary for recycling to Environment Minister Nancy Heppner. This is a step in the right direction as Ottenbreit, a former waste management operator, will fully understand the challenges facing recycling programs and can lend his experience to help shape the province's plans.

Currently, taxpayers fund recycling programs in Saskatchewan, but a plan to get industry to contribute has been in the works for some time. A Multi-Material Recycling Program (MMRP) would see industry and municipalities sharing the costs for recycling of paper, plastics, glass and tin. Establishing a MMRP would dramatically improve the prospects for recycling in the province, spreading responsibility for recycling more fairly across consumers, municipalities and industry.

But until a MMRP is up and running, low prices for recyclable materials present a market failure for waste management operators. An injection of cash is needed now to overcome free-falling market prices and sustain even basic recycling services. While the province tells us that there is no money available, many recycling programs continue their slide toward collapse.

The provincial government shouldn't allow a sudden drop in market prices to deliver a fatal blow to recycling in Saskatchewan, forcing recycling programs to collapse and spoiling the public's enthusiasm to recycle. The Saskatchewan public has embraced recycling, faithfully separating their household waste and diverting literally tonnes of garbage from municipal landfills every year. To overcowme this market failure, the province should provide grant financing to ensure recycling programs' survival – and the public's appetite for recycling sustained until the MMRP is established.

# **Up with infrastructure!**

Depressed Canadian economy needs infrastructure dollars in upcoming Federal budget

On January 27th, the federal government will release one of the most important budgets in Canadian history. With the Canadian economy showing more and more signs of deepening economic slow-down, the government is looking to provide a major economic boost.

Up until a few weeks ago, the Prime Minister and federal Finance Minister were rejecting any talk of a federal budget deficit. Since then, the deficit taboo has been lifted and options are being considered, including infrastructure spending, tax cuts, and support for specific industries and lenders.

## **Balancing act**

Seemingly all Canadians are lining up to tell the government how best to spend its money in 2009. Major corporations, banks, environmental groups, taxpayer associations, Chambers of Commerce, provincial and municipal governments - even the Canadian Armed Forces - are making their case for a piece of the stimulus pie.

Federal cabinet ministers are also hearing of the virtues of tax cuts,

which could boost the economy by putting money back in the pockets of Canadians, thereby raising consumer spending.

Support also exists for bail outs to major industries in order to save jobs. The feds are also hearing from provinces and, of course, municipalities, who maintain that infrastructure spending would create jobs and boost economic growth immediately and through the long-term.

With so many well-lobbied options on the table, the big question for the federal government is where to focus the stimulus spending. In short, what's the biggest bang for the buck?

While the Urban Voice goes to press, the federal government has yet to present its 2009 budget. Tax cuts, infrastructure spending and sector-specific support will undoubtedly be featured in the upcoming budget. The complex factors behind Canada's economic slow down, not to mention the complexities of federal politics at the moment, will require a sophisticated and comprehensive response.

## The case for infrastructure

SUMA's position is that the budget should give priority to infrastructure spending as the best way to boost the economy during this time of recession. Infrastructure spending will also provide the foundation for economic growth in the medium and long term. More than tax cuts, sector bail outs and any other option being presented, infrastructure spending will provide a ready economic stimulus, while guaranteeing that tax dollars stay in Canada, creating jobs and generating additional tax revenues.

In October 2008, the Federation of Canadian Municipalities (FCM) released a study boasting the stimulus credentials of infrastructure spending. Among the major findings:

 A \$1 billion investment in upgrading roads, bridges and water mains would create more jobs and provide a greater economic stimulus than a \$2 billion tax cut.

· Every \$1 billion investment in new infrastructure will create more than 11,000 total jobs, including 5,500 new jobs in the construction industry.

 Every \$1 spent on infrastructure in Canada results in 35 cents for federal and provincial/territorial tax coffers, due to increased income and sales tax.

· Every \$1 spent creates a 17 cent saving for the private sector as roads, bridges and other infrastructure are improved.

Beyond the ability to fight off a recession, increased infrastructure spending would begin to address the crumbling state of municipal infrastructure in Canada - an issue that has been neglected for too long.

The most recent estimate places the (national) municipal infrastructure deficit at \$123 billion on existing infrastructure, with the number continuing to rise. As water and sewage systems, municipal roads and transit systems continue to age, the cost of maintenance multiplies. Furthermore, FCM estimates that a further \$115 billion will be required to build new infrastructure to service population and economic growth.

The case is clear - and the time is now. The federal government needs to get infrastructure dollars moving to projects immediately.

# 2009 budget, facilitating growth on agenda at December Board Meeting

The SUMA Board gathered for its quarterly meeting in Regina on December 12-13.

The Board reviewed the proposed 2009 budget, which reflects recent changes to SUMA's administrative staff structure and a review of membership fees. Details will be shared with SUMA members in advance of the February 3 AGM at the SUMA Convention.

Reports were also provided in the following key areas:

### **Revenue Sharing**

Following the September 2008 SUMA board meeting, Municipal Affairs submitted the MSSP's proposed revenue sharing program to Cabinet with a recommendation to adopt a growth index equivalent to one per cent of the PST, averaged over the previous three years.

Minister Hutchinson has confirmed that the proposal has been submitted to the Treasury Board.

In support of our efforts, SUMA has undertaken the following advocacy strategy to help ensure that the MSSP revenue sharing program is implemented by the province:

• Gained agreement with SARM that the MSSP proposal is acceptable, and should be implemented without alteration by the province.

• Communicated the joint agreement to the Minister, which represents virtually all municipalities in the province – to the Minister of Municipal Affairs.

Minister Hutchinson agrees that the joint position will help ensure the MSSP program is implemented. Furthermore, the Minister is confident that the 2009 budget will include a new revenue sharing program.

## Facilitating Growth

Municipal Affairs' proposed 'Facilitating Growth' process was endorsed by the Municipal Forum on November 27. The purpose of the process is to:

 Facilitate widespread growth around urban municipalities and most resort areas;

• Support the government's priority to secure the future, and ensure that Saskatchewan is ready for growth;

• Helping municipalities to manage growth; and,

• Address the need for improved regional planning for land-use and infrastructure, and conflict resolution.

The process will convene several different stakeholder groups including Municipal Affairs, SUMA, SARM, key provincial ministries, Enterprise Saskatchewan and industry representatives from various sectors.

This group will have a very broad, general mandate to analyze the current situation and identify opportunities to better facilitate economic growth in Saskatchewan's municipalities.

The next meeting of the SUMA Board of Directors will be April 3-4 in Regina.
