Vision Care Coverage Enhancements

While most New Year's resolutions involve trimming down, SUMA will be adding on. Effective **January 1, 2016** your Vision Care Coverage will receive the following enhancements:

- Premium rate reduction of 10 percent
 - Adding money back into to your pocket.
- Increased Vision Care Coverage from \$450 to \$500 per person over 24 months
 - Go ahead, get those designer fashion frames.
- Eye exams can now be claimed through your Vision Care Coverage
 - Do you suffer from perfect vision and glasses just aren't necessary? On average, eye exams cost \$125; the GWL extended health care plan only reimburses \$50. These new changes will allow the remaining eye exam balance to come out of your \$500 vision care coverage for reimbursement through SUMA.

Have You Signed Up for MMRP?

If you want to be involved with the Multi-Material Recycling Program (MMRP) when it launches on January 1, 2016, you must have a [services agreement](#) with Multi-Material Stewardship Western (MMSW) by **December 31, 2015**.

Agreements signed in 2014 were not carried over; **you must have an agreement signed in 2015** to be involved at launch time. [Check with MMSW](#) or your regional waste authority to make sure you are signed up.

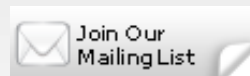
Prosperity Through Partnerships Conference
