# SPECIAL SECTION: Sask. Flood 2011

In response to the high water levels Saskatchewan municipalities are experiencing this spring, SUMA has received information from several sources which will be of assistance to those experiencing flooding.

#### **RED CROSS:**

Following flooding where the affected individuals are still in their homes:

 Red Cross may conduct a needs assessment of flood-affected residents, and may provide assistance such as the provision of clean-up kits

Following a flood where the individuals evacuate their home, and the municipality has NOT declared a State of Emergency:

- Red Cross can provide for basic needs including food, clothing, lodging, personal services, and children's needs during the first seventy-two (72) hours
- Red Cross can offer support through information and referrals.
- Red Cross may assess the needs of floodaffected residents and work with them to

<u>NOTE</u>: Anyone who plans to apply for disaster compensation should contact their municipality for information on qualifying for relief.

### CMHC:

It is important to note that in the case of large disasters, such as wide-spread and devastating flooding, the municipality is responsible for the provision of Emergency Social Services until a State of Emergency is declared.

### **Code Changes**

The Ministry of Corrections, Policing and Public Safety recently announced that the province is proposing the adoption of the 2010 National Building Code (NBC) and 2010 National Fire Code (NFC) effective September 1, 2011.

Saskatchewan adopts the NBC, with few amendments, as the minimum standard for the construction and renovation of buildings throughout the province. The NFC is adopted as the minimum standard for the fire safe operation of buildings and facilities.

The codes are developed by the National

# Creating 3D Maps of Saskatchewan's Groundwater

For years concerns have been raised about the health of lakes and rivers, but how often is attention paid to the water beneath the surface? Given that 75 per cent of communities and farms in southern Saskatchewan use groundwater for everything from drinking and bathing to agriculture and industry, more attention to this resource is warranted.

SRC is working with the Saskatchewan Watershed Authority to map groundwater in Saskatchewan's agricultural areas over the next five years to create a single 3D model. This mapping and 3D model will help to ensure safe drinking water, healthy aquatic ecosystems and a reliable water supply for industry.

The project stems from SRC's work with the Watershed Authority over the last 25 years to update groundwater maps. This latest generation of groundwater mapping is aimed at developing a standard for geologic/hydrogeologic mapping and groundwater characterization to apply throughout Saskatchewan's agricultural areas. A large, interactive database will be available to users, including consultants, planners, municipalities and the public, who will have access to a wide variety of high quality data.

The Saskatoon region has been chosen to pilot the new mapping standard because it is a well-explored area, rich in data. Over the next five years, it is hoped that the 20 watershed areas in

# Main Street Sask Promotes Downtown Revitalization

Last week, the Government of Saskatchewan announced a \$1.65 million investment over three years in an innovative redevelopment program for communities of all sizes to help them realize a new future starting on Main Street Saskatchewan.

"Main streets are the traditional centres of commercial and cultural life in communities across Saskatchewan," Tourism, Parks, Culture and Sport Minister Bill Hutchinson said. "This community-driven program will revitalize historic downtown commercial districts based on the principles of community organization, economic development, marketing and heritage conservation."

As mentioned in the budget 2011-12, the program will include matching funding assistance for the revitalization of downtown commercial areas in four demonstration communities. Communities

### NTPC Offers Municipal Development Assistance

The North Central Transportation Planning Committee (NCTPC) is committed to providing services and information to municipalities within its boundaries.

The challenges and opportunities which sustainable infrastructure development presents to the province of Saskatchewan prompted the NCTPC to launch the Municipal Support Program. This program will be offered free of charge to members of the NCTPC; non-members will be charged a per diem and mileage.

The Municipal Support Program is geared towards assisting municipalities in bidding on Road Building tenders, tender opening (ensuring criteria are being met prior to awarding of tender), locating gravel sources within your municipality, development of gravel specifications within your municipality, review of gravel tenders prior to posting, road maintenance agreements, liaising between municipality and third parties (contractors, government agencies, etc.), review of general tenders prior to

of varying population size will be invited to participate through a Request for Proposals (RFP) process. Eligibility will be determined on the basis of community capacity, community support, downtown viability and existing heritage buildings. For the selected communities, matching funding for three years for capital expenses and administrative costs will be provided.

Main Street programs are time-tested initiatives that have encouraged economic and social development of communities across North America through heritage conservation. Past examples of successful Main Street revitalizations here in Saskatchewan include Moose Jaw, Gravelbourg and Saskatoon's Broadway Avenue. All three achieved significant economic development and heritage conservation results.

"The new Main Street program is a good example of how the Government of Saskatchewan's cultural policy, Pride of Saskatchewan, is supporting heritage stewardship and strengthening our vibrant arts and culture sector," Hutchinson said.
