## **MCDP revises fee structure**

Effective August 1, 2011, pricing for services through the Municipal Capacity Development Program (MCDP) may vary, depending on the number of municipalities involved and the actual hours to complete the work.

Services including Community Action Plans (CAP), Memorandums of Understanding (MOU), Communications Plans, Socio-economic Profiles, Needs Assessments, Requests for Proposals, Planning Agreements, and Community Resource Inventories. A specialized package including a CAP, Needs Assessment, MOU and Communication Plan is available.

MCDP's current, active working groups will continue to receive services free of charge, and initial presentations, access to website resources, community forum and Interconnections newsletter continue to be free to all municipalities.

To help ensure public health and safety and protection of the environment, there are certain regulations and requirements for the disposal of liquid domestic waste. Every year, the ministry receives reports of illegal dumping of sewage. By increasing awareness of the regulations and the importance of proper disposal, the amount of illegal dumping of septic waste can be reduced.

If residents are aware that septic waste is not being disposed of properly, or if they observe improper dumping, the offense can be reported by calling the ministry's toll-free TIP line at 1-800-667-7561 or #5555 on your SaskTel cell phone.

## Summit Action Fund - Call For Proposals

The Saskatchewan Housing Corporation (SHC) is seeking proposals for the Summit Action Fund (SAF). SAF is designed to increase housing supply across the province, and is funded by the Government of Saskatchewan through SHC. Announced in April 2011, a total of \$6 million has been made available to encourage housing stakeholders to propose creative housing solutions that are not currently covered by existing housing programs.

There is no minimum requested funding amount, however, the fund will cover between 30 to 70 per cent of eligible project costs, or to a maximum of \$500,000.
