Life Membership Award

A SUMA Life Membership award recognizes a former Board member whose career exemplifies commitment and dedication to community, and significant contributions to urban government in Saskatchewan through SUMA. For 2019, the SUMA Board of Directors chose former City of Saskatoon Councillor Tiffany Paulsen to receive this award.

Tiffany was first elected to city council in 2000. At the age of 27, she was the youngest person ever elected to Saskatoon City Council and was subsequently appointed the youngest deputy mayor in the history of the city. She represented her ward for 16 years.

Tiffany has been named one of the 10 most influential women in Saskatchewan. In 2009, she was appointed Queen's Counsel by Saskatchewan's Minister of Justice – one of the fastest and youngest appointments in the province's history. In 2011, she gained provincial and national media attention when she brought her infant daughter to council, breaking barriers for women serving in municipal politics.

SUMA Service Awards

During her second term on council, Tiffany was appointed to represent the City of Saskatoon on the SUMA Board of Directors. Her commitment to her hometown of Saskatoon and other Saskatchewan hometowns is evident as in 2016, Tiffany was sitting on more than 20 local, provincial and national boards, commissions, and committees.

Today, she continues to serve her community. Tiffany is the current board chair of the Saskatoon Community Foundation, a director of the Saskatoon Police Service Foundation, and a member of the École Lakeview parent council. A partner at Robertson Stromberg LLP., she is also actively involved in professional organizations. She has held numerous positions within the Canadian Bar Association and is past president of the Saskatoon Bar Association.
